Prioritisation Schedule

Priority One

- A serious threat to health and / or safety. (E.g. traffic hazard, storage of hazardous substances, development creating pollution problems, dangerous structures).
- Permanent damage to the environment (e.g. loss of protected tree, unauthorised and irreversible work affecting the character of a listed building)

Where a case is categorised as Priority One, immediate action will be initiated to address the breach of control.

Priority Two

- Building work, which is unlikely to be given planning permission without substantial modification. (E.g. excessively large house extension)
- Unauthorised uses causing severe nuisance through noise, smells, congestion etc.

Where a case is categorised as Priority Two and the development does not meet the objectives of local, regional and national policies, action will be initiated to address the breach of planning control.

Priority Three

- A breach causing problems, which may be resolved by, limited modification (E.g. restrictions on hours of use etc.)
- Property whose condition adversely affects the amenity of the surrounding neighbourhood. The severity of the property's condition will depend whether it is given a priority three or two rating.

Where a case is categorised as Priority Three and the development meets the objectives of local, regional and national policies, then a 'retrospective' planning application will be invited.

Priority Four

Breaches of a minor nature raising minimal planning concerns. (E.g. house extension built to acceptable standards.)

Where a case is categorised as Priority Four and deemed minor with no significant effects, no further action may be taken.
