# NORFOLK MINERALS SITE SPECIFIC ALLOCATIONS DEVELOPMENT PLAN DOCUMENT (DPD):

SINGLE ISSUE SILICA SAND REVIEW – PRE-SUBMISSION ADDENDUM: MODIFICATIONS - INVITATION TO MAKE REPRESENTATIONS

#### **Summary**

Modifications are proposed by the County Council to the Silica Sand Single Issue Review. Some reflect comments made originally by the Borough Council, others will improve the Plan.

#### Recommendation

The Main Modifications given be supported.

#### **Reason for Decision**

To achieve a more appropriate set of policies in the Silica Sand Single Issue Review.

#### 1. Background

The County Council, as part of its work on the Single Issue Silica Sand Review of the adopted Minerals Site Specific Allocations DPD, has prepared Modifications to the Pre-Submission document. In Norfolk, the silica sand resource occurs entirely within West Norfolk.

The hearing sessions for the independent examination of the Single Issue Silica Sand Review took place on 14 and 15 March 2017. There were some issues which the Planning Inspector considers should be regarded as Main Modifications. There are also two additional modifications to the Single Issue Silica Sand Review that are not considered to be Main Modifications (i.e., when taken together they do not materially affect the policies set out in the plan). Further information is provided in the 'Main Modifications and Additional Modifications' document.

The 'Main Modifications and Additional Modifications', including associated changes to the supporting documents, are now published to allow representations on the soundness and legal compliance of the document be made, over a six week period, from 9am on 17 July to 5pm 1 September 2017.

A total of 18 Modifications are being proposed, but the more significant ones can be summarised as follows:

- 1. Deletion of Area of Search (AoS) D an area of land amounting to some 85 hectares in the parishes of East Winch and Pentney. This is due to 53 hectares of AOS D being designated as open access land under the Countryside and Rights of Way Act 2000.
- 2. A modification to reduce the area of AoS E (at Wormegay; Shouldham; Marham) by 1 hectare from 816 hectares to 815 hectares. This is due to:
  - The southern boundary of AOS E being changed to exclude the site of Fairstead Medieval Market from the area of search. AOS E would be reduced by approximately 1 hectare.
  - More accurately reflect the northern boundary of AOS E in relation to the historic environment, and further information provided by the Historic Environment Service.
- 3. Cross referencing to other policies in the Minerals Local Plan to stress the fact that careful consideration needs to be given to general mineral policies also. (These include cumulative impact and historic environment).

There are a number of other detail modifications (see schedule at Appendix 1) but these relate to detail numerical calculations, or are consequential to the main geographical changes as above.

The 'Main Modifications' and 'Additional Modifications', including associated changes to supporting documents, have been published to allow representations on the soundness (whether it is justified, effective, positively prepared and consistent with national policy) and legal compliance of the modifications to be made, over a six week period, between **9am on 17 July and 5pm on 1 September 2017** (inclusive).

Only the modifications are subject to this representations period, so any representations on other matters will not be accepted. Any previously made

representations on these matters do not need to be repeated if they are unchanged. Any representations on the modifications must be received during the representations period; late representations will not be accepted.

#### 2. Consideration of the proposed modifications

The Cabinet agreed a response to the original consultation on the substantive silica sand plan in June. However at the Examination there was significant questioning from the inspector about various environmental and historic environment matters, and the County Council went away to address things. The result is the modifications now proposed.

In terms of the proposed modifications a schedule is attached as Appendix 1, they do reflect careful consideration of the Examination discussions and the Inspectors questions. Most were not subjects raised directly by the Borough Council at previous stages. Notwithstanding that the view of your officers is that they should be supported
