The grounds for the review are:

It is the opinion of the Police that the management of the premises and the application of the Licensing Laws persistently falls short of current Licensing Objectives and that in spite of continual dialogue between the Police and Mr KECELI (who is the Licence Holder, Designated Premises Supervisor, and owner of the business at the premises) in trying to address these issues there is:

- Evidence to demonstrate Police concerns that Mr. KECELI has failed to consistently display the strength of management and supervision of his premises required to pay sufficient attention to compliance of the Licensing Laws and Objectives.
- Evidence to demonstrate that Mr. KECELI has allowed breaches of Licensing Conditions and has been allowing activities which are unlicensed, i.e. Recorded Music and Dancing.
- Unacceptable levels of incidents at the venue that require Police attendance or intervention which include Crime, Disorder and Drunkenness both inside the venue and outside in the immediate vicinity of the premises.

This situation has led to the overall poor standard of management of the premises which in turn has led to disproportionate numbers of incidents of crime and anti-social behaviour associated with these premises. This has a profound and detrimental impact on the safety and well being of the local community within night time economy of Kings Lynn.

The opinion of the Police is that action by way of Licensing Review is required to ensure that the premises no longer presents the same risk of Crime & Disorder occurring and affecting those who may use the venue or may use the area, by making sure that the premises are more appropriately controlled and restricted for licensing purposes.

The premise of the Ali's Meze Bar & Charcoal Grill is situated in the heart of the night time economy of Kings Lynn in Norfolk Street. The venue is within a terrace of buildings which consist of commercial premises on the ground floor and some residential properties above. The licensed premise is on the ground floor only and provides both restaurant and take-away food facilities. A significant part of Mr. Keceli's business takes place between midnight and 4am on the weekends. This is generally even more concentrated between 2 am and 4 am when night time revellers are looking for hot food and a chance to consume more alcohol after the night clubs have closed.

The premise is almost opposite the Dr. Thirsty's (Kudos) Night Club. Norfolk Street itself has six hot food venues that service the night time economy and is the main area to which high numbers of intoxicated people gravitate towards for hot food at the end of their night out.

Ali's Meze Bar & Charcoal Grill benefits from a Premises Licence (WNPL005085) which only authorises:

1. The Sale of Alcohol for consumption on and off the premises – it should be noted that, in essence, all sales of alcohol are subject to conditions stating that such sales are only allowed if they are ancillary to the purchase of food.
2. Late Night Refreshment

These licensed activities should finish at 04.00 am on Friday & Saturday Nights and the venue should be closed by 04.30am. Full details of the permissions applicable to the premises can be found contained within the Premises Licence. *(Copy attached.)*

Mr. Keceli took over the running of his business at the premises at the beginning of November 2009. At that time he told the Police Licensing Officer that he had previous experience in the restaurant business in this country in Kings Lynn but this was the first time he had run his own business. At the time he was advised to ensure that he runs his premises within the permissions and conditions contained within the premises licence and that if he required and advice of guidance as far as licensing matters are concerned he should contact the Police.

It soon became obvious that, even though he believed that he was doing a good job, Mr. Keceli's interpretation of the Licensing Laws and the terms of his licence was not what it should be. Twice in 2010 Police recorded incidents of Breaches of his Licence Conditions where he sold alcohol without food. Throughout 2011 there were incidents at the premises which involved drunkenness, disorderly conduct, assaults, breaches of the permissions & conditions in his licence and poor management. *(Details of these incidents can be seen on the attached 'Summary of Police Involvement' which is attached to this application.)* Mr. Keceli was reminded of his responsibilities by the Police Licensing Officer when they discussed the running of his premises in April 2011.

It was clear to Police that Ali's Meze Bar was consistently attracting high numbers of persons throughout the early hours of the morning at the weekends. Observations by Police patrols determined that high spirited, drunken people would hang around the front of the venue either waiting for food or coming out of the venue to smoke. Often these 'high spirits' would escalate into criminal & disorderly behaviour which would require Police intervention and often involve the arrest of offenders.

In March 2012 it became necessary for the Police Licensing Officer, Michelle Bartram, to contact Mr. Keceli by telephone and again remind him of his responsibilities towards the Licensing Laws and the terms and conditions of his premises licence. Reports had been received by Police concerning the sale of alcohol to underage persons and the fact that he had been seen again serving hot food after licensing hours had ended. Drunkenness at the premises was still an issue as was disorderly behaviour and poor management. An advice letter was sent to Mr. Keceli. *(Copy attached.)* In April 2012 this intervention was followed with a personal meeting with him by Police Licensing Officer, Tony Grover, to discuss Police concerns in more depth. The result of this meeting was a further letter of advice to Mr. Keceli which warned of the possible consequences if he continued to operate his business outside the provisions contained within his premises licence and failed to take appropriate steps to reduce the number of incidents associated with his premises. *(Copy attached.)* At the time the Licensing Officer requested that he write to him giving details of how he would address the concerns of the Police. No such communication was received.

Over the following months the concerns of the local Police Commanders were not alleviated. Poor management of the premises was still a serious problem and incidents similar to those already mentioned continued to be recorded against the premises.

In August 2012 another meeting between Mr. Keceli and the Police Licensing Officer, Tony Grover, was held where the spectre of a Licensing Review was seriously discussed. It was a last ditch effort to compel Mr. Keceli into taking Police concerns most seriously and introduce effective measures that would demonstrate the required level of attention to:-

- a) Stopping any further breaches of the Licensing Laws.
- b) Comply with the Permissions and Conditions within his Premises Licence.
- c) Reduce the number of preventable incidents from occurring at his premises.

Details of that meeting were recorded in another letter to Mr Keceli. *(Copy attached.)* On this occasion Mr. Keceli did send a letter to the Police Licensing Officer stating his intentions. *(Copy attached.)* The Licensing Officer also received a telephone call from the Security Manager from Dove Security informing him that Dove Security had been engaged to supply one doorman at Ali's Meze Bar on Friday & Saturday nights between 2am and 4am.

It can be seen from the 'Summary of Police Involvement' that no improvement in the performance of the premises has been seen. In fact, the opposite is evident. In addition to the observations and reports of Police Officers attending to deal with the Crime and Disorder still associated with the venue, covert Police observations were held within it. Police Officers observed unlicensed activities taking place in that music was being played 'disco style' at a level which could only be regarded as being 'Recorded Music' for licensable purposes and that several customers were seen to be dancing, again an activity which requires licensing. Neither of these activities are given as permissions contained within the current premises licence. The officers also witnessed alcohol being sold to at least one customer without food being purchased. This was a clear breach of the conditions within the premises licence.

The local Police Commander, Chief Inspector Porter, had by this time already spoken to Mr. Keceli regarding his concerns about the management of the premises and the unacceptable level of incidents associated with it. The observations of the covert Police Officers obviously came as a disappointment. Chief Inspector Porter has attached a statement to this application which highlights his concerns regarding Ali's Meze bar and its current negative effect within the night time economy.

At a meeting with Mr. Keceli on 2nd November 2012 the Police Licensing Officer informed him that it had come to the point where Police would be submitting an application for his premises licence to be reviewed. The reason is because of the ONGOING SERIOUS CONCERNS REGARDING UNLICENSED ACTIVITIES, POOR MANAGEMENT OF THE PREMISES AND ITS CONSTANT LINKS WITH CRIME & ASB IN NORFOLK STREET. Mr. Keceli was informed that the Police would seek amendments to the timings of licensable activities and the addition of conditions forcing robust management of his premises. The details would be given in the application of which he would receive a copy.

Norfolk Police request that the Licensing Committee take into account all the evidence contained within this application and attached to it and would seek to place the following Amendments and Additional Conditions to the Premises Licence in order to address the concerns that they have regarding the way in which the premises are currently being run:-

Amendments:

1. To amend the permitted times for the Sale of Alcohol (on & off) to read - 11 am to midnight every day.
2. To amend the timings for Late Night Refreshment to read – Monday to Saturday (& New Years Eve) – 11.00 pm to 02.45 am
Sunday – 11.00 pm to 01.45am.
3. To amend opening hours to read – Monday to Saturday (& New Years Eve) – 11.00 am to 03.00 am
Sunday – 11.00 am to 02.00 am

Additional conditions:

1. Two members of registered door staff must be on duty at the premises on Saturdays & Sundays (& New Years Day) between 01.00 am and the time when the premises are closed for business.
2. A digital CCTV system must be installed to current British Standards that will have a minimum of 28 days recording capability. Images must be capable of being downloaded and provided to representatives from the Police & the Licensing Authority upon request. All public areas must be covered by cameras. One camera must cover the front entrance/exit to the premises. One camera must be placed to monitor outside the front of the premises. Notices must be displayed advising customers that CCTV is in operation at the premises.
3. Staff at the premises will keep & maintain an incident & refusals log.
4. All staff must be trained in the licensing laws applicable to the sale of alcohol. Training records must be kept and provided for examination to the Police & the Licensing Authority upon request.
5. At least one personal licence holder must be on duty at the premises during times when alcohol is permitted to be sold.

Norfolk Police feel that this action is both Necessary and Proportionate in order to positively address the serious concerns they have regarding how Mr. Keceli runs his premises.

Norfolk Police feel that this action will practically Promote the Licensing Laws and Objectives for the benefit and well being of the whole community.

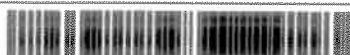

ANNEXES

ANNEX 1 - MANDATORY CONDITIONS

1. Under Section 19(2) of the Licensing Act 2003, no supply of alcohol may be made under this premises licence at a time when there is no designated premises supervisor in respect of the premises licence, or at a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.
2. Under Section 19(3) of the Licensing Act 2003 every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.
3. In relation to the sale of alcohol, the responsible person shall take all reasonable steps to ensure that staff do not carry out, arrange or participate in any irresponsible promotions in relation to the premises. An irresponsible promotion means an activity carried on for the purpose of encouraging the sale or supply of alcohol for consumption on the premises in a manner which carries a significant risk of leading or contributing to crime and disorder, prejudice to public safety, public nuisance, or harm to children.
4. The responsible person shall ensure that no alcohol is dispensed directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of a disability).
5. The responsible person shall ensure that free tap water is provided on request to customers where it is reasonably available.

To take effect from the 1st October 2010 onwards:

6. (1) The premises licence holder or club premises certificate holder shall ensure that an age verification policy applies to the premises in relation to the sale or supply of alcohol.

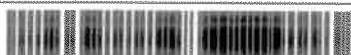
(2) The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and a holographic mark.

ANNEX 2 - CONDITIONS CONSISTENT WITH THE OPERATING SCHEDULE

7. Alcohol shall not be sold or supplied:
 - a) unless the premises have been structurally and bona fide used, or intended to be used, for the purpose of habitually providing the customary main meal at midday or in the evening, or both, for the accommodation of persons frequenting the premises;
 - b) for consumption on the premises otherwise than to persons taking table meals there and for consumption by such a person as an ancillary to his meal;
 - c) for consumption off the premises otherwise than to persons purchasing take-away food.
 - d) unless suitable beverages other than alcohol (including drinking water) shall be equally available for consumption with or otherwise as an ancillary to meals served in the premises.
8. Staff will prevent open vessels of any kind containing alcoholic or non-alcoholic drinks from being taken from the premises at all times. Notices reinforcing this condition will be placed in full view of customers at exit/entry points.

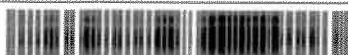

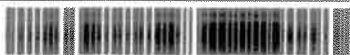
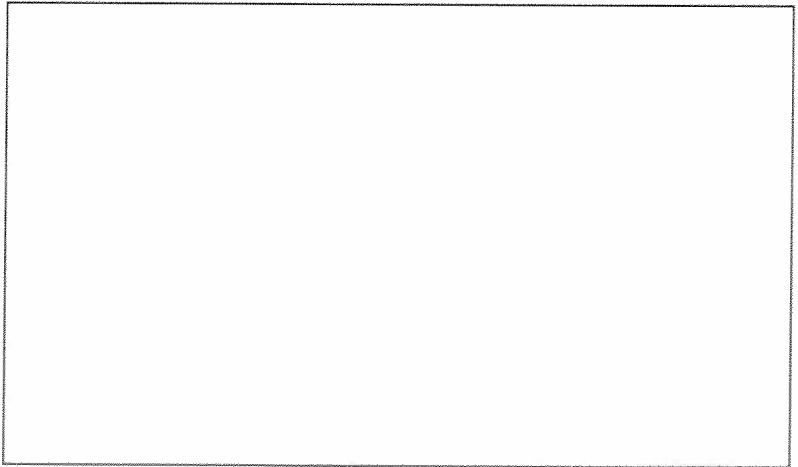

Dear Mr. Keceli,

I am writing to you following my visit on Thursday 5th April 2012. The purpose of my meeting with you was to discuss recent information from Police Officers who have reported:

1. Seeing you and your staff providing customers with hot food and drink beyond your permitted licensable hours. Your licence clearly states what those permitted hours are and you confirmed with me that you and your staff are aware of those hours.
2. Attending a number of incidents within the last 5 months where customers have been involved in anti-social behaviour between the hours of 3am and the closing of your premises where the ability of you and your staff to control these customers and deal with them effectively has been put into question.

With regard to your entitlement to provide Late Night Refreshment (hot food and drink) as one of your permitted licensable activities, I must remind you that the Licensing Laws provide "for the provision" of hot food and drink between permitted times. This does not mean that you can take orders up to the end of permitted hours and still provide the hot food and drink after those times.

With regard to the incidents, there is concern by the Police that you have relied upon the assistance of door staff from the night club premises opposite to assist you on occasions to resolve issues arising at your premises. This raises issues of door staff from other premises (whose services are not retained by you to work at your premises) being absent from the venue they should be working at if an incident occurs there and making that premises vulnerable due to a temporary lack of security cover. **It is the consideration of the Police that you and your staff must be in a position to be able to minimise the risk of incidents occurring in the first place and be able deal with matters that arise appropriately.** This does not mean that you should not call for Police assistance when required as that may be the appropriate course of action to take. The emphasis is on prevention in the first place.

You stated that you try your best to make your premises a safe place to be for your customers and provide the best service you can. I appreciate also your assertion that you will always do everything to work with the Police and deal with your customers appropriately and that you consider that you do have the ability to deal with potential trouble makers and diffuse potentially confrontational situations as they arise. However there is often the need to reassess the management practices that you currently employ and adjust them to ensure that your operation at the premises does not put your ability to carry on your business at risk.

(I note that you state that you have already taken some advice from a representative at Dove Security regarding incident recording and recognising fake personal identification documents, and that you have joined the town centre pub watch.)

In your case the Police suggest that you consider that the following measures which may assist in reducing the level of concern there currently is regarding your ability to comply with the Licensing Laws and the Licensing Objectives:-

- a. You review the manner in which you provide hot food and drink and communicate to your customers that sales will cease on good time for you to be able to stop providing at the time when your permitted hours end, i.e. no orders taken in the 15 minutes before the end of permitted hours.
- b. You enlist further help between your vulnerable times (as highlighted in 2 above) where it has been shown that the overwhelming majority of the incidents occur at you premise. This could be by making yourself available "front of house" to deal with customers and / or employing dedicated security staff to assist you at your premises.

In any case you must not operate outside the permitted times for licensable activities at your premises in accordance with the provisions contained within your Premises Licence. If there are any more such incidents brought to the attention of the Police I will have no option other than to make an application to review your Premises Licence and seek revocation or suspension of that licence.

Likewise, similar action may be considered by the Police if there is no improvement made in the management practices that you employ at your premises in order to minimise the risk of incidents of anti-social behaviour occurring.

I would be interested to see a written communication from you about how you will address the matters that I have raised in this letter.

The local Police will continue to monitor the performance of your premises in relation to your responsibility under the Licensing Act 2003 and its Licensing Objectives and to ensure that you comply with the terms of your Premises Licence.

I will be informing the Licensing Authority of our meeting and its content. You may wish to seek further advice and guidance from them if you need any further clarification concerning licensing matters.

If you do not understand anything this letter or disagree with anything that I have written, please contact me and I will endeavour to clarify any concern that you may have.

Dear Mr. Keceli,

I am writing to you following my visit on Friday 17th August 2012. The purpose of my meeting with you was to follow up my visit of 5th April 2012 and to review the situation following the letter I sent to you which warned you of possible considerations if there still appeared to be licensing issues at your premises.

1. It is apparent that you have paid some heed to the information contained in my letter of 16th April. Reported observations from Police Officers can confirm that you have been working hard to comply with the terms and conditions within your premises licence.
2. Those same observations also express concern that you often appear to be finding it difficult to deal with troublesome persons in spite of your best efforts.
3. There have been another five incidents recorded against your premises by Police since my last visit to you where customers have been involved drunken and anti-social behaviour. Four of those have occurred between the hours of 3am and 4am.

The Police consider that there is the need for you to enlist further help to ensure that you can properly manage the problems you consistently face from customers at your busiest and most vulnerable time which is when the majority of them turn out from nearby licensed premises and come to your premises looking for refreshment. You need to think of other ways in which you can manage this problem. Failing to address this matter is not a consideration in the view of the Police.

The options for the Police to consider now are:

- Do we apply for a review of the premise licence with a view to cutting back your hours so that the problems experienced by you and the Police are removed completely?
- Do we apply for a review of the premise licence with a view to placing conditions on your licence forcing you take measures which the Police consider appropriate?
- Do we give you time to come up with and put in place sufficient measures to address this issue and then monitor your performance over a set period of time?

I would prefer that the last option is considered first and that you demonstrate how you will deal with this issue.

To that end I will expect to see written details of the extra measures you will put in place. Once I have those details I will ensure that the Police monitor the situation for a period of 3 months. If there is still no reduction in the number of incidents at your premises the Police will have to exercise one of the other options highlighted above.

I appreciate that you try your best to make your premises a safe place to be for your customers and provide the best service you can. I appreciate also your assertion that you will always do everything to work with the Police and deal with your customers appropriately. I also appreciate that there may be financial considerations for you to assess before making decisions about how you deal with this situation.

I must remind you that your responsibility to the provisions of the Licensing Act 2003 and the Licensing Objectives is an outweighing factor to financial considerations and is not one you can ignore.

I will be informing the Licensing Authority of our meeting and its content. You may wish to seek further advice and guidance from them if you need any further clarification concerning licensing matters.

If you do not understand anything this letter or disagree with anything that I have written, please contact me and I will endeavour to clarify any concern that you may have.

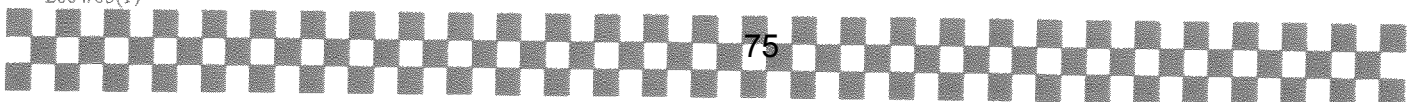
I am Chief Inspector Adrian Porter of the Norfolk Constabulary currently stationed at Kings Lynn. I currently have responsibility for policing in Kings Lynn and I'm accountable to people and businesses that are located within the town centre. This responsibility covers the night time economy and the large scale policing operation which takes place each Friday and Saturday night.

As the local police commander for Kings Lynn I commissioned a piece of analytical work to highlight the impact that the night time economy has on local policing. Analysis of crime and disorder in Kings Lynn shows that there is a massive upsurge on Thursday, Friday and Saturday nights in the categories of crime and anti social behaviour.

The common factor is alcohol and the massive increase in crime and anti social behaviour when compared to the rest of the week of violent crime. These crimes include Assaults, Assaults on those who work in the bars and clubs and police officers who are charged with keeping people safe. These assaults and the level of abuse impacts on the SOS service that operates in Kings Lynn, the people staffing this service are merely helping to keep patrons safe yet are often abused by intoxicated people who have been drinking in Kings Lynn.

The hotspot location for this violence centres on Norfolk Street and those venues in the town centre that attract large numbers of patrons so including Heights and the roadways around these venues. The impact on policing is that we have to consistently provide large numbers of officers to ensure that

the streets remain safe and that we are able to intervene early to prevent more serious offences being committed.

This policing environment has the greatest impact on my ability to provide policing services in Kings Lynn as it requires a constant presence to ensure the peace is kept on these key nights. Even with this policing presence violence on Thursday, Friday and Saturday nights demand is consistently higher.

The level of violence and anti social behaviour in Kings Lynn on Thursday, Friday and Saturdays has a massive adverse impact on those providing services such as the police, Ambulance, Accident and emergency and other services which have to be diverted to cope with this heightened demand.

In particular Ali Meze Kebab shop impacts on the night time economy both in terms of crime and anti social behaviour. The venue sells alcohol and attracts large numbers of people who have already spent considerable time inside the pubs and clubs with Kings Lynn. The venue is particularly busy after 03:00am when officers have to be posted outside the venue to prevent crime and disorder.

Officers and supervisors have consistently raised concerns to me about the venue as the large seating area, alcohol sales and operating hours mean that officers have commented that the numbers of intoxicated persons invariably means that they are called to return either by doorstaff or CCTV who witness incidents. Supervisors state that this constant attention is needed to prevent crime and disorder.

As the commander I have spoken to the owner to highlight my concerns however the incidents of disorder and the venue attracting anti social behaviour outside its doors has continued.

With the impact of this venue in the night time economy and the scale of demand on the police service and other emergency services on these busy nights it is my opinion that alcohol sales should be stopped at this venue in their entirety and that the hours of operation be restricted to finish at 03:00am. Clearly until the operating schedule is changed officers and patrons in the night time economy will continue to face the issues that Ali's is presenting.
