Notes of a Meeting of the West Norfolk Disability Forum held on Wednesday 12<sup>th</sup> September 2012 at 2.30 pm in the Committee Suite, King's Court, Chapel Street, King's Lynn.

		ACTION
1.	COUNCIL TAX SUPPORT SCHEME	
	A presentation was given by the Revenues and Benefits Manager on changes to the Council Tax Support Scheme. It was explained that the current scheme was fully funded by Central Government. However, under changes proposed in the Welfare Reform Act 2012 and the Local Government Finance Bill, funding from Central Government would be fixed at the start of the year and would be reduced by 10%, leaving an estimated shortfall of £1.13M in 2013/14.	
	It was explained that the Council was free to design its own Council Tax Support Scheme which had to be in place by 31 January 2013. After considering various options, Members	

resolved to design a scheme which would fall within the new budget. It was noted that a draft scheme was currently out for consultation until 18 October and was available on the Council's website. Members of the Forum were invited to comment on the proposals.

ACTION

The draft scheme was outlined and the changes explained. The maximum amount of support would be 75% of entitlement. It was emphasised that certain vulnerable groups would be protected under the proposed scheme, as follows:

- Pension Age people (as prescribed by Central Government)
- Household with at lease one child under 5
- Households entitled to a disability premium in their applicable amount (disability living allowance)

These groups would see no reduction in their support under the new scheme. War pensions would also continue to be fully disregarded.

It was highlighted that work incentives would be introduced and the amount someone could keep before their benefit was be affected would be increased by £10 per week.

The Revenues and Benefits Manager advised that extensive consultation was taking place with as many affected groups as possible, as well as writing to individuals in receipt of benefits. A drop in session was held in King's Lynn on 11 September and further sessions were due to take place in Downham Market on 8 October and Hunstanton on 10 October.

It was explained that the scheme could be amended each year and it was anticipated that a more fundamental review would take place after year 2, benefiting from the experience gained.

In response to questions and comments from Members of the Forum, the Revenues and Benefits Manager confirmed that other benefits in kind, such as free bus passes, would not affect the amount of support provided under this scheme. A Hardship Fund would be established for those vulnerable people who may not be included within the protected categories. Members of the Forum were advised that the Council had tried to work with the other district councils in Norfolk to see if a single scheme could be

	developed, but differences in the demographics of each district had made this approach problematic. It was noted that only way to ensure that the scheme could be contained within budget was to limit the level of support to 75% of entitlement. With regard to revaluation of properties for council tax, the Revenues and Benefits Manager advised that this was a Central Government function and there had been no revaluation exercise undertaken. However, individual properties were revalued when a property was sold and where the property had been improved or extended.	ACTION
	The Chairman thanked the Revenues and Benefits Manager for attending the meeting to explain the draft scheme and urged the Members of the Forum to access the Council's website and comment on the scheme.	ALL
2.	MINUTES The minutes of the meeting held on 22 May 2012 were agreed as a correct record, subject to the inclusion of Genene Henshaw in apologies for absence.	
3.	MATTERS ARISING AND NOT COVERED ELSEWHERE ON   THE AGENDA   There were no matters arising.	
4.	<b>FEEDBACK FROM CELEBRATE ABILITY EVENT</b> The Celebrate-Ability event had been held on Monday 3 <sup>rd</sup> September in the Corn Exchange. Allison Bingham reported of the feedback received. It was felt that fewer people had attended then previously, which was thought to be because of the day the event had been held. It was reported that it had been a successful networking event and while most of the feedback had been positive, comments had been made that there were no stands offering the opportunity to try disability equipment. It was noted that many of the aids were no longer available free of charge through Social Services and had to be purchased, but offering the opportunity to 'try before you buy' might be a welcomed.	

		ACTION
	Members of the Forum discussed how the event might be improved in the future, including using alternative venues, holding mini events in smaller venues around the borough, including a demonstration in the programme, providing transport and improving publicity.	
	The Chairman requested that a letter of thanks be sent to those businesses and organisations in the borough which had displayed posters publicising the event. Allison Bingham advised that posters had been sent to a large number of contacts and organisations and it was not possible to identify all those which may have displayed them. Sylvia Pomeroy suggested that an open letter be sent to the Lynn News thanking everyone who had helped to publicise the event.	АВ
5.	WEBSITE UPDATE	
	Allison Bingham reported that the West Norfolk Disability Forum page on the Council's website need to be updated and read out suggested wording, as follows:	
	The forum comprises of Borough Councillors, representatives of people with disabilities or are involved with groups or individuals who are concerned about disability issues within West Norfolk.	
	Allison also suggested that links could be included to the show the contact details each of the voluntary organisations involved with a link to their own websites. She advised that she had spoken to the web team who had advised that this would be possible.	
	<b>AGREED:</b> That the West Norfolk Disability Forum website be updated as described.	AB
6.	BUDGET	
	Allison Bingham reported that just under £2,000 had been spent in the current financial year, which included expenditure for the Opportunity Awards, leaving some £19,000 in the budget. It was highlighted that any monies not spent at the end of the year may be lost and the future budget may be reduced.

	AGM 2013 and Opportunity Awards	
	Allison Bingham advised that when planning events at the Corn Exchange, she liaised closely with the venue to establish when there was flat floor availability, which reduced the hiring fee considerably. With regard to the AGM for 2013, it was suggested that this be brought forward to Monday 1 <sup>st</sup> July, when the Corn Exchange was available. The AGM to be held at King's Court in the afternoon and the Opportunity Awards to be held at the Corn Exchange in the evening.	
	<b>AGREED:</b> That the AGM 2013 and Opportunity Awards be held on Monday 1 <sup>st</sup> July 2013.	
7.	SUPPORT FOR THE ELDERLY IN THE WINTER	
	Councillor Harwood had previously raised the issue of holding an event to support the elderly in the winter. Allison Bingham advised that the Corn Exchange would be available on Monday 16 <sup>th</sup> September 2013 and suggested that a 'Winter Check-up' event might be held, bringing together all the information and organisations.	
	Sylvia Pomeroy suggested that a hot meal eg soup and a roll, could be provided. She commented that this type of environment would be more relaxed and friendly, which may encourage more elderly people to attend.	
	Jill Darling commented that it was important to provide free transport to the event.	
	Members of the Forum discussed ideas and potential participants for such an event. It was considered that events should be held at Downham Market and Hunstanton, in addition to King's Lynn. Allison Bingham to contact the venues to ascertain the possibility of holding such an event.	AB
	Members of the Forum were invited to bring any further ideas and contact details for organisations to the next meeting in November.	ALL

## West Norfolk Disability Forum

#### **Constitution and Aims and Terms of Reference**

#### 1. Introduction

1.1 The Forum was initially established by the Borough Council of King's Lynn and West Norfolk.

#### 2. Membership

- 2.1 The Forum will consist of:
  - Representatives of people with disabilities or people concerned with disabilities in the Borough.
  - Individuals with disabilities.
  - Seven Borough Councillors, appointed bi-annually by full Council (who can send substitutes to meetings if they are unable to attend).
  - Statutory organisations such as: Borough Council; Norfolk County Council; Health Authorities; Disability Employment Services; Education Services; Any other relevant organisations.
- 2.2 The Chair of the Forum will be elected at the Annual General Meeting and will be elected to stand annually from the seven Borough Councillors. The Vice-Chair will be a representative of people with disabilities, or a person concerned with disabilities in the Borough and will be elected to stand annually.

#### 3. Operation

- 3.1 The Forum will receive administrative support from the Secretary who shall be an officer of the Borough Council and advice and support from the Council's NRAC Auditor
- 3.2.1 The Forum will provide reports and make recommendations if necessary to any of the relevant Borough Council Panel's and Committees.
- 3.3 The Forum's Constitution and Aims and Terms of Reference shall only be changed with the formal agreement of the West Norfolk Disability Forum.
- 3.4 The Forum can appoint working groups comprising of Councillors and other members which shall be authorised to meet between meetings of the Forum for the purpose of providing, the Forum, the Borough Council and its Committees with advice on matters.

#### 4. Meetings

- 4.1 Meetings of the Forum shall be held in public unless the Forum resolve otherwise.
- 4.2 The Forum will hold not less than five meetings a year in addition to its annual general meeting in accommodation provided by the Borough Council.
- 4.3 The Forum will hold its annual general meeting in July. The schedule of future meetings and the Forum's Annual report will be presented to the Annual General Meeting.
- 4.4 Agendas for the meetings will be published on the Borough Council's website five clear days in advance of the meeting.

#### 5. Objectives

- 5.1 To promote equality for disabled people
- 5.2 To provide a meeting place at which disabled people and other representatives can meet with and discuss with representatives of other organisations matters of interest or concern.
- 5.3 To identify the needs and requirements of disabled people in the Borough and bring these to the notice of the Borough Council and other organisations.
- 5.4 To determine measures by which the Forum might address those needs.
- 5.5 To communicate its views and findings to relevant bodies and agencies.
- 5.6 To raise disability awareness.
- 5.7 To seek improved access in the Borough.
- 5.8 To support and promote the West Norfolk Disability Forum's Opportunity Awards Scheme.
- 5.9 To support, promote and develop the Borough Council's online access guide.
