	The Forum discussed the impact of hate crime on disabled people and the importance of ensuring that all hate crimes and hate incidents were reported so that they could be investigated by the Police or one of the other organisations signed up to the Hate Crime Multi Agency Protocol.	
	Comments and questions were invited from the Forum some of which are summarised below.	
	In response to questions Abraham Eshetu explained that hate related crimes carried higher sentencing as they were crimes against a section of the community rather than an individual.	
	In response to a question from Councillor Langwade, the Forum were informed that if an incident is reported relating to hate crime, it would be investigated by the Police and if the Police were unable	

	to prosecute they could impose other sanctions such as warnings and anti social behaviour orders etc. They would also liaise with other relevant organisations such as Housing Associations to help solve any issues.	
	Abraham Eshetu explained that by law no community has any more rights than the other and all communities were equal. No community should be discriminated against. He referred to the 'Welcome to West Norfolk Guide' which he had helped to produce and was given to people who were new to the area.	
	In response to a question from Sylvia Pomeroy, Abraham Eshetu explained that Safer School Partnership Officers carried out work in schools to raise awareness of the importance of reporting hate crime. There were also Diversity Liaison Officers who carried out work in the local community.

#### 1. INTRODUCTION

The Forum have had another productive year in 2012-2013 dealing with and being consulted on a wide range of issues.

The Forum now report directly to the Borough Councils Regeneration, Environment and Community Panel and the Panel have requested update reports on the work of the Forum on a regular basis.

#### 2. **MEETINGS**

During the year five full meetings have been held:

Wednesday 12 September 2012 – 2.30 pm – Committee Suite Thursday 29 November 2012 – 2.30 pm – Committee Suite Wednesday 23 January 2013 – 2.30 pm – Committee Suite Wednesday 20 March 2013 – 2.30 pm – Committee Suite Wednesday 22 May 2013 – 2.30 pm – Lynnsport

Working Groups of the Forum have met on an ad hoc basis

# 3. MATTERS OF CONCERN AND KEY ISSUES/DISCUSSIONS THROUGOUT THE YEAR

The Forum have dealt with a wide range of issues this year, some of which are detailed below:

#### (i) Consultations and Investigations

<u>Visit to King's Lynn Railway Station</u>

The Forum conducted a visit to King's Lynn Railway Station to look at perceived problems that could be faced by disabled people in accessing the newly installed ticket barriers. Funding had subsequently been secured to automate the existing front doors to the railway station, making access to the Railway Station easier. Allison Bingham has been in regular contact with representatives from the Railway Station and has updated the Forum on how work is progressing.

Bodyworks Studio at Lynnsport

Following some concerns from members of the Forum regarding the new Bodyworks Studio at Lynnsport, particularly the new toning chairs area. The Forum were offered a tour of the new facilities and held their meeting in May at Lynnsport. The Fitness Manager attended the meeting to inform the group of consultation process which had been conducted prior to and following the installation of the new studio. He highlighted to the Forum the specific measures and changes which had been put in place following feedback from users of the facility.

#### (ii) Presentations

#### (iii)Updates

The Forum receive regular updates on items of interest and concern and the Secretary has investigated issues raised by the Forum as appropriate.

The Forum have an annual work programme, and Forum members are given the opportunity at each meeting to suggest future agenda items to be investigated by the Secretary.

#### 4. EVENTS

• <u>Celebrate-ability</u>

The third Celebrate-ability event took place on 3<sup>rd</sup> September 2012 in the Corn Exchange, King's Lynn. The next event is likely to be held in 2014 and the Forum will consider ways to improve the event and continue to make it popular, including using alternative venues.

 <u>Support for Vulnerable People in the Winter</u> The Forum have decided to hold this event on Friday 20<sup>th</sup> September 2013, at Downham Market Town Hall from 10.30am to 4.00pm which will provide information on keeping homes warm and safe, being energy efficient, healthy eating and the effects of the cold on older and vulnerable people. The event is hoped to raise awareness of locally available services and the support available.

#### Opportunity Awards

This event was to be held in July 2013, however due to the small number of nominations received the Chairman of the Forum has agreed to defer the ceremony until 2014.

#### 5. WORKING GROUPS

The Forum have established the following working groups which meet on an ad hoc basis:

- Opportunity Awards Working Group
- Celebrate-ability Working Group
- Visiting Working Group to visit attractions and assess their facilities prior to inclusion in the West Norfolk Access Guide
- Planning Applications Working Group to discuss the implications of public access planning applications.

#### 6. **NEXT YEAR**

The Forum already have a varied work programme over the next year, and Forum Members are regularly given the opportunity to suggest further items for consideration. Some of the items which have been suggested by the Forum and may be considered in 2013/2014 are listed below:

- Presentation on the Blue Badge Online Application Process
- Invite West Norfolk Deaf Association to a future meeting to promote their organisation
- Future possible presentation from Involve project
- Credit Union Presentation
- Information on respite care available in West Norfolk
- Norfolk Disabled Parents Group
- Information on Tactile Pavements.

Once the schedule of meetings for 2013/2014 has been confirmed at the Annual General Meeting, the Secretary will investigate the above items and schedule them onto the work programme as appropriate.
