#### 10 INTERIM REVIEW OF THE SCRUTINY STRUCTURE

#### **Summary**

The report recommends temporary amendments to the Council's structure in relation to Scrutiny Review and Development Panels, Cabinet Scrutiny Committee and the Scrutiny and Overview Liaison Committee.

#### Recommendation

That the Council's Constitution be amended on an interim basis, pending the review of the Scrutiny arrangements in the summer of 2015 in order to create the following:

- i) Three, 12 Member, proportional Policy Review and Development Panels,
  - Environment and Community Panel
  - Regeneration and Development Panel
  - Resources and Performance/ Audit Committee Panel
- ii) The Environment & Community Panel and the Regeneration & Development Panel to meet jointly for the June and July meetings, with alternate chairing.
- iii) The Scrutiny and Overview and Liaison Committee be deleted.
- iv) That Cabinet Scrutiny Committee be made up of 9 Members, with an Opposition Chairman and Vice-Chairman, its membership being on a proportionate basis.

#### 1 Background

- 1.1 Following the 7 May 2015 Borough Council elections the Council is now made up of 50 Conservatives, 10 Labour and 2 Independents.
- 1.2 During the summer, it is proposed that a review of the scrutiny structures is carried out which will commence following the June 2015 Cabinet and Council meetings. This report proposes an interim arrangement pending that review.

#### 2 Current Structure

2.1 The current structure comprises 2 proportionate Policy Review and Development Panels of 15 Members, and a Cabinet Scrutiny Committee of 11 Members which to date has, on the taking of a "nem con" vote, been non proportionate. The Cabinet Scrutiny Committee has an opposition Chairman and Vice-Chairman. A Scrutiny and Overview Liaison Committee exists in the overall structure but does not meet with any regularity.

#### 3 Proposed Structure – Interim Arrangements

- 3.1 As an interim measure, pending the overall review of the Scrutiny structure the following is proposed:
  - 3.1.1 The creation of three, 12 Member proportionate Policy Review and Development Panels as follows:
  - Environment and Community Panel
  - Regeneration and Development Panel
  - Resources and Performance/ Audit Committee Panel
  - 3.1.2 It is proposed that due to the number of meetings and induction sessions already scheduled for the forthcoming few months, the June and July meetings of the Environment & Community and Regeneration & Development Panels meet jointly, chaired alternately by each Chairman.
  - 3.1.3 It is proposed that the Scrutiny and Overview Liaison Committee be deleted from the structure.
  - 3.1.4 The proposal also makes a Cabinet Scrutiny Committee of 9 Members, to a proportionate body with a Chairman and Vice Chairman of opposition Group Members.

#### 2 Policy Implications

2.1 The changes to the structure have no impact on the Council's Policies.

#### 3 Financial Implications

3.1 The financial implications of the changes are that an additional Special Responsibility Allowance will be awarded to the third Chairman and Vice-Chairman of the Panel at the current rate of £2,000 (Chairman) and £870 (Vice-Chairman).
