5. <u>UPDATE FROM THE LICENSING MANAGER</u>

The Licensing Manager updated the Board on the following changes to legislation and procedures:

- Following the nationwide concern with child exploitation the Norfolk Children Safeguarding Board set up a Licensing Task & Finishing Group which the Licensing Manager was a member of. A countywide approach was being looked at with regards to the Disclosure and Barring Service Checks. In the future the Police would collate information (provided it was relevant) on Licensed Drivers and it would be logged and reported to the Disclosure and Barring Service so it could be released if an application came through.
- From 1st October 2015 the Borough Council would be required to issue three year taxi driving licenses. Presently the Borough Council issued one year Combined Drivers Licenses which made it easier to flag up when addresses changed or if the driver had accrued any penalty points etc. Private Hire Operators Licences would be issued for a period of five years and vehicle licence renewals would remain at one year.
- At the moment it was unlawful to subcontract outside of the district. As from 1st October 2015 this would no longer be the case.

The Licensing Manager agreed to put a fact sheet together regarding the changes in legislation and procedures and circulate to Members.

In response to a question from Councillor Crofts regarding safeguarding children, the Licensing Manager did not have any concerns at the moment and felt that the current measures in place were adequate. Councillor Crofts requested that it be noted that the Board showed concerns and sought assurances from the Licensing Manager.
