**CABINET MEMBERS REPORT TO COUNCIL**

**14 July 2022**

**COUNCILLOR STUART DARK – LEADER OF THE COUNCIL, CHAIR OF CABINET**

**1 Progress on Portfolio Matters.**

**Queens Platinum Jubilee Celebrations**

I believe it appropriate to start this report by commenting on this Council's support to the celebrations to mark Her Majesty's 'Platinum Jubilee' an unprecedented milestone in the country's history, unlike to be repeated. Amongst the support given this included the council; giving out specially minted 'coins' to c. 35,000 infant and primary school children across the Borough, extending its grant scheme to provide c£14K of funding to support local community events, providing assistance to both Hunstanton and Downham Market Town Council's and delivering 4 days of major activities in Kings Lynn, including fireworks, bands, the biggest ever parade of children's youth groups and a combined service in the Minister to celebrate the Jubilee and the Mayor's civic service. I hope Councillors concur West Norfolk's communities and the Borough's officers can be very proud of how we all marked this once in a lifetime event and I give thanks and pay tribute to the groups, volunteers and staff who made this happen.

**Levelling Up Funding Bids and Shared Prosperity Funding**

A major part of my work during this period has been working with portfolio holders and officers from the Borough and Norfolk County Council to submit two major funding bids into government under their 'Levelling Up' programme, in time for its deadline. The larger relates to a c.£40M Transport and Infrastructure improvement scheme to address the long-standing issues of the Southgates access/egress to Kings Lynn and reprofiling the gyratory system. I believe it is worthy of note that the County was only able to bid in for one scheme across the 8 Norfolk districts covering over 2,000 square miles. The fact that this is focussed here, alongside the County Council's ongoing involvement in the Town's Board multi-user Hub and that scheme's associated multi-million pound commitment from that body demonstrates the tangible, magnifier, impact of collaborative working.

The second bid submitted is for c£20M to help create a new Oasis Leisure centre in Hunstanton to replacing the ageing current facility. Consultation in the process of this bid's creation demonstrated a very high degree of support, with over 1,000 respondents to a survey in just two weeks and letters of support from Hunstanton Town Council, James Wild MP (an essential part of the published process) and the newly formed Hunstanton Advisory Group.

At Cabinet during this period these bids were considered and approved alongside the reprofiling of some of the 'Towns Board' projects (The School of Nursing already being successfully delivered). In context, this means with that scheme's £25M and the two 'Levelling Up' bids we are currently actively working on funding and schemes potentially bringing c.£85M of new funding into West Norfolk.

### **Expansion of the Planning Department**

As part of this administration's continuing, self-generated reviews of departments and services to be the best we can be (bearing in mind this council operates on just 7p of every tax pound raised in West Norfolk with nearly 3p of the 7p going to the IDBs in Levys) Cabinet took the decision during the period to significantly increase staffing in the planning department. This follows on from similar work in legal services, fly-tipping enforcement and support to litter picking and communications and engagement.

### **Support to Ukranian refugees**

I am proud to report that West Norfolk is currently supporting 151 refugees from the illegal invasion of Ukraine and resulting humanitarian catastrophe. 35 of these are children placed in local schools. The reception centre based in Kings Court, supported by the Hanseatic Union charity, borough officers, DWP and volunteers (including Ukrainian refugees kindly helping others) is gaining a very good, well-deserved reputation for the support it offers. Funding has been aligned to ensure this vital support function continues as long as it is needed. On behalf of those I have spoken to, I would like to offer my wholehearted thanks to all those locally hosting refugees, supporting the children in schools and working in the centre to achieve this it is very much appreciated.
