#### ST GEORGE'S GUILDHALL & CREATIVE HUB MAJOR SCHEME

#### PURPOSE OF REPORT/SUMMARY:

This report is to give an update on financial developments on the St George's Guildhall & Creative Hub Major Project ("the Major Scheme") since the Full Council agenda was published.

The information contained in this report updates the information provided within the report to Cabinet in relation to item CAB23 on 7 July 2025.

#### BACKGROUND:

On 7 July 2025, Cabinet made the following recommendation to Full Council:

#### CAB23: GUILDHALL AND CREATIVE HUB

RECOMMENDATION TO FULL COUNCIL: To amend the Capital Programme for the Major Scheme up to £30.5m and to amend the Medium Term Financial Strategy in accordance with the Finance Strategy at Appendix 6 (Exempt).

#### **UPDATE**

Since the Full Council agenda was published, there have been two developments in the funding position:

- 1. A grant application has been successful, but remains subject to due diligence before it is fully secured. This funding is therefore being treated as unsecured.
- 2. The £2m budget reallocation within the Town Deal Funding to the St George's Guildhall & Creative Hub Major Project is now being treated as secured, following receipt of further assurance from MHCLG.
