Denver Playing Field Association

The Association is keen to re-order the pavilion to meet user needs and current standards. The works will improve and enlarge changing facilities, install central heating, and create a meeting/ community room. Works are expected to cost £48,000 in total, of which £37,000 has been raised primarily from a Sport England grant. A grant of £4,500 is offered on the condition that a new satisfactory lease is put in place, as the current lease will expire in 2014 and is currently being re-negotiated.

Requested - £5,000

Awarded - £4,500 (on the condition that a satisfactory lease is agreed)

South Wootton Parish Council

The Portfolio Holder declared an interest in this item.

Funds are requested to create a skate ramp at Wootton Park. This project has been under development for some time, with local teens organising petitions and taking an active role in planning. The skate ramp will cost £16,800, and the funds needed have been secured except for the amount requested.

Terrington St Clement Parish Council

A new infant play area is planned for Terrington St Clement on the memorial playing field to replace existing dilapidated and unsafe play equipment. The proposed play area will cost £23,184 and will comprise a range of small infant play items plus safety surfacing and fencing. A contribution of £4,000 is offered on the condition that the other funds needed are secured.

Requested - £7,728

Awarded - £4,000 (on the condition that the other funds needed are secured)
