LOCAL PLAN HRA PROCESS/ADMINISTRATION OF HRA MONITORING & MITIGATION & GI COORDINATION PANEL

Summary

The Council's Local Plan needs to have a Habitat Regulations Assessment (HRA) carried out. A proposal from the Norfolk Coast Partnership (NCP) to do this has been received.

The HRA Monitoring & Mitigation & GI Coordination Panel Meeting process needs administrative support. This was previously carried out by the Graduate Planner in the Planning Policy Team. This post is currently vacant. The NCP already administers the Panel's habitats payment process. They are willing to take on the Panel administration role.

Recommendation

Appoint the Norfolk Coast Partnership to carry out the Local Plan Habitat Regulations Assessment and to administer the HRA Monitoring & Mitigation & GI Coordination Panel.

Reason for Decision

To ensure that the HRA of the Local Plan is carried out in line with statutory requirements.

To facilitate the smooth administration of the HRA Monitoring and Mitigation & GI Coordination Panel.

Background

Local Plan HRA Process

The Local Plan has to be subject to a Habitat Regulations Assessment (HRA) at each stage of the process. Previously specialist consultants have been employed to carry out this work. The NCP have an officer who has recently provided assistance to North Norfolk District Council (NNDC) in relation to this area of work.

Discussions with NCP officers have confirmed that the officer concerned would be very happy to help with the work on the HRA, equivalent to the work she has completed for NNDC, namely:

- Writing the HRA scoping report
- Writing the brief for consultants to conduct the HRA
- Support for selection of consultant
- Any other related tasks, on request

NCP would charge for her time at a rate equivalent to her cost of employment to them, including overheads. For 2018-19, this works out at £25.40/hour, equivalent to £187.96 for a standard 7hr 24 minimum day. This is the same as the amount they would charge NNDC this year (an increase on last year's rate based on 2% inflation plus a recognition that she is going up in grade). Their total charge to NNDC for the work was approx. £2,755.

They would also be very interested in helping with any review of our Local Plan/Development Control environmental policies, or environmental content in general policies, but this work is not included in the above figures.

HRAMMGI Panel

The officer currently dealing with the habitat payments for us and her manager have had a discussion about the idea of NCP helping with the administration of the HRA Monitoring & Mitigation & GI Coordination (HRAMMGI) Panel, i.e. for her to fulfil both facilitator and meeting administration roles. This is considered to have the opportunity to be quite an efficient model, reducing duplication. We have the chance to try this out, at least in the short-term whilst a replacement is recruited for the Graduate Planner in Planning Policy who left in mid-July with the NCP officer being on the same grade as the one who would assist with the HRA, so NCP could charge an hourly rate equivalent to the rates shown above. If it went on longer, they could continue charging an hourly rate for time taken, or they could agree an increase to the percentage they charge for the payment facilitation, to include the panel administration work.

Options Considered

HRA of Local Plan

Borough Council Officers to carry out this function – Borough Council Officers do not have the same level of expertise in these matters as the NCP can offer combined with their recent experience of doing this for NNDC and the advantages of consistency with a neighbouring authority with a shared Area of Outstanding Natural Beauty (AONB) and other similar/shared designations.

Norfolk County Council to carry out this function on behalf of the Borough Council – this was previously discussed with Andrew Hutcheson, Environment Manager (Green Infrastructure Strategy & Advice) who estimated that this would take around 25 days of ecologist time. They looked carefully at their capacity and would struggle to accommodate that amount of work.

HRAMMG Panel Administration

Borough Council Officers to carry out this function – NCP are already (since July 2017) successfully operating the HRAMM Fund on behalf of the Borough Council. This relatively small amount of additional administrative work could be efficiently carried out by the same officer. It is not an efficient use of professional planner time to carry out administrative duties and detracts from their inputs to the plan process.

The Democratic Services Team is already heavily committed with the limited resources at its disposal so additional meetings to organise and note would not be feasible.

Procurement have confirmed that there are no issues with the approach suggested.
