Decision Taken

Specify precise details of the decision taken

Following the outbreak of war in Ukraine and the government launching the 'Homes for Ukraine' and the 'Ukraine Family Scheme' to provide help and safe harbour for those fleeing the fighting, West Norfolk is now seeing a greater number of refugees from Ukraine arriving under both schemes. The refugees often have no belongings other than what they have been able to carry from their homes.

In March, the Chief Executive, in consultation with the Leader, using emergency powers stipulated under the Council's Constitution, agreed to provide financial support to the Hanseatic Union and Access to facilitate support and services for the refugees. Both organisations specialise in helping migrants settle into the area, assisting with matters such as housing, access to education, healthcare, benefits, and employment, along with a raft of other support such as clothing and toiletries.

The Government is providing upper tier authorities with funding of £10,500 per person to enable them to provide support to families from Ukraine to rebuild their lives and fully integrate into communities. Funding for district councils has been allocated as per the table below:

Item	Amount
Additional housing officer	£45,000
A Community Support Officer at each council	£35,000
Grant pot per Council to support successful and sustainable hosting	£20,000

Total District Council Funding	£120,000

The council has entered into a Service level Agreement with the Hanseatic Union to provide direct services for refugees. The Hanseatic Union, together with Access are running the refugee Welcome Centre in King's Court and are also arranging social events, arranging transport to collect biometric passports, providing benefit advice etc, to support the refugees settle into their new environments. The SLA has funded a full-time member of staff for the Hanseatic Union.

The Hanseatic Union are working with the refugees daily and have an excellent overview of the issues the refugees face and are aware where the funding allocated by the County Council could be directed to support the best outcomes.

The decision is therefore to enhance the SLA with the Hanseatic Union and provide them with £20,000 of the funds provided to enable sustainable hosting and VCSE. The SLA will be conditional of reports on the allocation of the funding, together with information on the outcomes the funding has facilitated.

Reasons for the Decision

The borough council has limited resources to provide wrap-around services to refugees. The Hanseatic Union and Access specialise in this area of work and are best placed to ensure the funding goes to where it is of most benefit to those coming to the area from Ukraine. This funding will enable them to continue to provide the service to the refugees on behalf of the borough council.
