Delegated Power

1.9 Public and Civil Emergencies

The Chief Executive in consultation with the Leader: To exercise any power to protect the interests and well-being of the inhabitants of the Borough in cases of emergency

In exercising the delegation an update to be made at Cabinet as soon as reasonably practical.

7.12 Health improvement and promotion including public health and community care and LILY

The Chief Executive in consultation with the Portfolio Holder for People and Communities; day to day management.

Decision Taken

Cabinet on 21st July 2022 resolved (CAB36) that the priorities for the West Norfolk investment Plan (WNIP) be endorsed and that the WNIP submission be made by the deadline on 1st August to secure the UK Shared Prosperity Funding (UKSPF). A further report on the final interventions to be funded through the UKSPF be brought back to Cabinet.

In December 2022 the Government confirmed the overall UKSPF allocation for BCKLWN of £1.8m for the period 2022/2025.

The further report on the final interventions to be funded through the UKSPF will be brought to Cabinet on 7th February 2023.

One of the projects identified for 2022/2023 which is considered ready to go in terms of spending and capacity to deliver UKSPF identified outputs and outcomes was submitted by the Lily Service. The Lily Service requests £27.3k to support the roll out of energy saving measures to help households within West Norfolk during the 2022-2023 financial year.

The Lily Service proposes to help low-income households access information and materials to install small but impactful energy saving measures in their homes. Information, advice and guidance (IAG) will be provided to support individuals to reduce their costs of living. This will be online and offline, including directing clients to access Warm Hubs (Hotspots) and other community facilities where they can access IAG and engage in community and social events. Home energy improvement products such as hot water tank covers, radiator reflectors, draught proofing and low energy light bulbs will be provided to help households to reduce their fuel bills by retaining heat and reducing energy consumption. Measurable KPI's will be a reduction in household CO2 emissions, number of people reached and increased take up of energy efficiency measures (households). The project complements the existing DWP Household Support Fund along with the work being undertaken by the Housing Standards team to promote energy efficiency. It also compliments the Norfolk Warm Homes Fund. The Careline Community Service team have staff available to help to deliver and provide some installation support to residents who are unable to physically do it themselves. The initial project estimates are to provide the products mentioned to 200 households. Details of costs are shown in the table below:

Approval to commence this project immediately will ensure that the project can be delivered to benefit the maximum number of west Norfolk residents during the winter months and to provide much needed support to help reduce rising household energy costs. The report to Cabinet on 8th February will provide details of all the final interventions to be funded under the UKSPF.

Decision: To use £27,300 of the UKSPF funding towards the roll out of energy saving measures to help households within West Norfolk during the 2022-2023 financial year.

Reasons for the Decision

If project commencement is delayed until the full report on the final interventions to be funded through the UKSPF comes to Cabinet in February 2023 it is likely that the project would not deliver the support to vulnerable residents at a time when it is most needed. The intention is that the energy reduction products would be offered alongside the help provided through the DWP Household Support Fund which runs from Oct 2022-Mar 2023. The Lily Service is confident that if this project could commence in early January, it would enable the support to be offered to all households eligible for the DWP Household Support Funding from January onwards and could also be offered retrospectively to recipients of funding from December.

The project is in line with the priorities identified in the WNIP approved by Cabinet in July 2021 and the outputs and outcomes required by the UK Shared Prosperity Fund guidance This will enable households to start using measures to save energy and money when it is currently much needed.

Options considered

Delay start of project to February 2023:

If project commencement is delayed until the full report on the final interventions to be funded through the UKSPF comes to Cabinet in February it is likely that the project would not deliver the support to vulnerable residents at a time when it is most needed. The project proposal is to assist 200 households, but it is unlikely that this could be achieved if the DWP Household Support Fund has been depleted as contact and support with households will be considerably reduced beyond this. Leaving many vulnerable households in dire financial situations due to soaring energy costs.

Defer project to 2023-24

It is possible that the UKSPF allocation in 2022/2023 for this project could be deferred into 2023/2024. However, this will be dependent upon the submission of a request via the UKSPF Delivery Team. DWP Household Support Funding for 2023/2024 has not

been confirmed therefore it cannot be guaranteed that the project could run alongside this in the next financial year. The project is to help people to save money on household energy and at the current time when it is most needed.
