Procedure for Determining Hackney Carriage/Private Hire/Special Event Licences Applications and Disciplinary Hearings

Introductions

- 1 The Chair of the Panel should introduce him/herself.
- 2 The Chair should introduce the Members of the Panel.
- The Chair should introduce the Legal Advisor to the Panel and explain his/her impartial role.
- The Chair should introduce the Council's Representative and explain their role.
- 5 The Chair should introduce the Democratic Services Officer and explain her role.
- The Chair should invite the applicant or the person subject of consideration to introduce themselves and any representative they may have.

The Procedure

- 7 Those present to be made aware that all questions and comments should be directed through the Chair.
- 8 The Chair should invite the Legal Advisor to outline the procedure.

The Application/Person Subject of Consideration

- 9 The Chair will invite the Council's Representative to present his/her report, outlining the case and the background, having regard to existing policy and conditions.
- 10 The Council's representatives may call witnesses to support the Councils case.

Questions

- The Chair should only allow questions when he/she is satisfied that the substance of the case has been presented by the Council's Representative.
- First from the applicant/person under consideration, then Members of the Panel.
- 13 Multiple questions should be avoided.
- 14 Questions must be relevant to the matter in hand.

The Applicant's Case/Person Subject of Consideration

- The Chair then invites the Applicant/person under consideration or their representative to present their case. They can make statements and can call witnesses (the applicant/person subject of consideration may be a witness if represented).
- Any witness called must be open to questioning, firstly by the Council's Representative and then Members of the Panel.
- 17 Multiple questions should be avoided.
- 18 Questions must be relevant to the matter in hand.

Summing Up

- The Chair then invites the Council's Representative to sum up his/her case. He/she may comment on what has been said but no new evidence should be introduced.
- The Chair then invites the Applicant/person under consideration or their representative to sum up their case. They may comment on what has been said but no new evidence should be introduced.

Reaching a Decision

- 21 The Chair will invite the Legal Advisor to address the Panel on any outstanding matters.
- The Chair will then thank all those who have spoken and invite the Panel to retire to consider the case, accompanied by the Legal Advisor and Democratic Services Officer. The Chair will explain that the Legal Advisor and Democratic Services Officer will take no part in the decision making.
- The Panel will then debate the case presented to them at the hearing and will seek to reach a decision and reasons for their decision.
- Once a decision has been made, the Panel (and relevant officer/Legal Advisor) will return back in to the room and the Legal Advisor will announce in public any legal advice he/she has given in private.
- The Chair will read out the decision and the reasons for the decision (unless the Panel is unable to reach a determination at the conclusion of the hearing).

Application for a Private hire vehicle licence in respect of vehicle registered as Category N1

Introduction

- 1. This report is for Members to consider whether to grant a Private Hire Vehicle Licence to Mr David Paisley in respect of a Peugeot Boxer Van bearing the vehicle registration mark which has been professionally converted to a minibus to carry 5 passengers and 1 wheelchair or 3 passengers and 2 wheelchairs. The DVLA vehicle category is currently N1, whilst Borough Council Procedures and Conditions state all vehicles for licensing must be M1.
- 2. Mr Paisley submitted an application to licence the above vehicle on 25th May 2023. The vehicle was tested in accordance with the Borough Council's procedures and conditions at Kerry Motor Services on the same day, and with the exception of not bearing the Council's signage passed both the inspection and MOT tests without advisories. The application and relevant test results are attached to this report at Appendix 1.

Additional Information

- 3. Mr Paisley originally ordered a newly manufactured vehicle from Peugeot in November 2021 to be converted by GM Coachwork Group. With delays to manufacturing delivery was expected in the summer of 2022. In December 2022 it became apparent that Peugeot were still no closer to fulfilling his order. Due to rising costs of maintaining his current vehicle Mr Paisley changed his order to a used vehicle of the same specifications which GM Coachworks would convert and cancelled his original order.
- 4. Mr Paisley was unaware that as the used vehicle had already been registered with the DVLA as category N1, this would not be possible to change. Consequently, he was unaware his new vehicle would not meet the Borough Council's Procedures and Conditions.
- 5. Mr Paisley has provided the Licensing Enforcement Officer with several documents showing the original purchase order and the change of order to the new vehicle. These also specify the conversion process to be followed, and detail the original vehicle being classified as M1 and the replacement being to the same specification but with a category of N1. He has also supplied several letters from GM coachworks as supporting documentation. These are attached to this report at Appendix 2.

- 6. Mr Paisley has supplied the licensing enforcement officer with the Voluntary Individual Vehicle Approval (VIVA) report showing a pass to M1 standards as well as a copy of previous tests performed on the specified wheelchair conversion which are attached to this report at Appendix 3.
- 7. The panel should be aware that category N1 vehicles are classified as light goods vehicles up to 3500kg. When manufactured they are not required to incorporate passenger safety systems in the rear compartment of the vehicle and are not subjected to the same safety tests as category M1. This question was put to GM Coachworks by Mr Paisley at the request of the Licensing Enforcement Officer, and they have supplied a response which is included in this report as Appendix 4.

Conditions

- 8. The Borough Council's Licensing Conditions and Procedures Approved by Full Council on 25th April 2022 state the following relative to vehicle type:
 - 3.18 The vehicle shall have four side opening doors (designed for the purpose of permitting persons access to/from the interior)-any lift-up tailgate shall not be included; or a vehicle shall have three side opening doors (designed for the purpose of permitting persons access to/from the interior) and two rear opening doors (designed for the purpose of permitting persons access to/from the interior).
 - 3.19 Any vehicle's suitability for licensing will also be determined by the positioning of its seating, fittings and fixtures for the ingress and egress of passengers and their safety.
 - 3.21 The vehicle must have European Community Whole Vehicle Type Approval (ECWVTA) and must show category M1 on the V5C/logbook.
 - 3.22 If the requirements in Condition 3.21 above cannot be satisfied, or if the vehicle has been altered from the original manufacturers specification, then a Driver and Vehicle Standards Agency (DVSA) Individual Vehicle approval (IVA) or Voluntary Individual Vehicle Approval (VIVA) inspection must be undertaken and a satisfactory report produced.
 - 3.36 An altered vehicle is any vehicle which has been altered from the original manufacturer's specification, re-registered or has been an insurance loss ...

Determination

- 9. The Panel are requested to consider the application, including any submissions put forward by Mr Paisley and dispose of the matter by either:
 - i. Refusing the application,
 - ii. Granting the application, or
 - iii. Any other action deemed appropriate
- 10. The Panel are reminded that grounds for their decision must be given as there is provision for appeal to the Magistrates' Court against that decision.

1 wheelchair option: Front wheelchair positioned to the far right would allow comfortable access to all rear seats.

2 wheelchairs option: With both wheelchairs in position, access to the two rear seats would not be available.

I can confirm your current vehicle conversion, , is suitable for 2 wheelchairs.

I can confirm David Paisley placed an order on the 09/11/2021, for GM Coachwork Ltd to supply a new Peugeot Boxer L3 H2/LWB 435 speed manual professional van to be converted to an M1 wheelchair accessible vehicle. This vehicle is still on order with Peugeot who have not yet confirmed a production date for the base vehicle.

The worldwide motor trade industry has experienced unprecedented delays with supplies of semi-conductors and other parts since the Covid lockdowns and then further exacerbated by the Russia/Ukraine war where wiring looms are produced.

This has caused a massive worldwide backlog of vehicles requiring parts already in very small supply.

For the last 18 months Peugeot had said overseas production was starting up again but we are only now starting to see production moving slowly forward. This has affected over 900 vehicles we have on order with Peugeot and other manufacturers.

This vehicle has been converted and tested by the VCA with a Voluntary IVA test.

As the vehicle has been first registered as a N1 panel van, this cannot be changed with the DVLA. N1 vehicles are exempt from type approval and therefore outside the scope of graduated vehicle excise duty (VED).

It is the DVLA's view that the legislation states that as the vehicle was first licensed under the graduated VED scheme according to its type approval, it must continue to do so despite being converted from a N1 to a M1 vehicle.

The vehicle was a Peugeot Boxer based wheelchair Accessible vehicle (WAV) / Minibus with an Unwin innotrax floor system bolted into the load area of the vehicle utilising angle brackets under the vehicle and washers where appropriate. The innotrax floor had 10 lengths of tracking and an additional length of Unwin surface mount tracking was mounted to the side wall on each side of the van above the windows along the full length of the load area.


The range of seats that could be fitted to the vehicle were Phoenix seating's Blenheim and Optimum seats and Star seating's Solar seat. All the seats were located into the tracking using either "T" bolts or Unwin lockables.
