Central government has invoked the Flood Recovery framework in response to flooding caused in October 2023 due to Storm Babet. The Flood Recovery grants must be defrayed by 25 January 2024 for the cost of the grants to be claimed back from central government.

The Flood Recovery Framework is designed to provide financial support to residents and businesses impacted by flooding from Storm Babet (19th to 25th October 2023). The financial support will be provided via one-off grant payments, aimed at aiding recovery from flooding (£500 per residential property and £2,500 per business meeting criteria). 100% council tax discount for a minimum of three months is available to qualifying residential properties.

The impacts for eligible residential properties and businesses are positive, giving financial support to residents and businesses to recover from the impacts of flooding.

FLOOD RECOVERY FRAMEWORK – GRANT AND DISCOUNT POLICY

JANUARY 2024

1. GUIDANCE SUMMARY

In October 2023 government ministers announced the activation of the Flood Recovery Framework in response to Storm Babet. This is applicable to everywhere in the country impacted by the storm (subject to eligibility criteria) and the government guidance is available <u>here</u>. This Policy covers flooding as a direct result of Storm Babet between 19 and 25 October 2023.

Local authorities are responsible for confirming their Flood Recovery schemes and assessing whether households and businesses are eligible. This policy contains details of the discounts grants which are available for residential and business properties:

Residential Properties:	Community Recovery Grant of £500 Council Tax Discount of 100% for a minimum of three months
Business Properties	Business Recovery Grant of £2,500 Business Rates Relief of 100% for a minimum of three months

This policy does not include the Flood Recovery Grant which is available from Norfolk County Council.

2. GRANT CLOSING DATES

The closing dates for applications and final payments under the grant schemes is 25 January 2024.

Council tax discounts and business rates reliefs can be awarded for any day up to 31 March 2025.

3. ELIGIBLITY CRITERIA

COMMUNITY RECOVERY GRANT - £500 PER HOUSEHOLD

The property must have been either:

- Internally flooded, or
- Considered unliveable for 48 hours or more as a result of wider flooding in the area

'Considered unliveable' means there is either no access to the property, key services have been affected or there was damage meaning it was advisable to vacate the property all as a direct result of Storm Babet. It does not include flooding to gardens and garages.

The following are not eligible for the Community Recovery Grant:

- Second Homes
- Empty Properties

• Student properties

Only one grant will be paid for an eligible property which is a House In Multiple Occupation.

COUNCIL TAX DISCOUNT – 100% FOR A MINIMUM OF THREE MONTHS

A council tax discount will be granted if a property was:

- Internally flooded, or
- Otherwise considered unliveable for 48 hours or more because of wider flooding in the area.

The eligibility criteria for the council tax discount are the same as for the Community Recovery Grant.

The council tax discount will be awarded for a minimum of three months, even if the property is occupied.

The council tax discount will continue to be awarded after three months if the property remains unoccupied because of the flood damage caused by Storm Babet.

100% council tax discount will also be awarded for any temporary accommodation the liable person for council tax for the flooded property is now occupying, providing:

- They are also liable for council tax for the temporary accommodation, and
- They are occupying the temporary accommodation as their main home as a direct result of being unable to return home due to the flooding.

BUSINESS RECOVERY GRANT - £2,500 PER BUSINESS

The business property must be in a flooded area and:

- Be directly impacted by the flood, for instance there is flood damage to the property, equipment and/or stock, or
- Be indirectly affected as there was no access to the property or restricted access customers / staff <u>and the business directly suffered a loss of trade as a result.</u>

BUSINESS RATES RELIEF – 100% RELIEF FOR A MINIMUM OF THREE MONTHS

Business Rates relief will be awarded to a hereditament with a rateable value under £10 million where:

- The business occupying the hereditament is directly impacted by flooding to the property, equipment or stock due to Storm Babet, or
- The business trading from the premises could not function due to a restricted or lack of access to premises, equipment and/or stock, and no alternative premises are available

The business activity using undertaken from the hereditament must be adversely affected, and very small or insignificant impacts are not considered eligible.

The Business Rates Relief will continue to be awarded after three months if the business is still unable to trade from the hereditament as a direct result if the flood damage caused by Storm Babet.

Business Rates Relief is also considered as assistance under Subsidy Control rules. More information is available <u>here</u>.

4. APPLICATIONS AND EVIDENCE

An application form may be required. Grant payments will usually only be made by bank transfer to a validated bank account. We will require supporting evidence for any claims for the grants or discounts. This can include, but is not limited to:

- Photographs
- Insurance reports
- Reports from professionals attending the property such as the Fire Service
- Proof of temporary accommodation

Grants and discounts will only be awarded where sufficient supporting evidence is provided and we are satisfied that the eligibility criteria have been met.

5. FRAUD

We will not accept fraudulent applications for the grant and will carry out checks to ensure all applications for grant payments are accurate. We may refuse to pay a grant if we suspect an application is fraudulent for any reason. We will check information at the time of application and may also carry out spot checks at a later date.

We will recover any grants and remove any discounts found to have been claimed fraudulently. We will also share the information about applications and grant payments with other bodies as requested and allowed by law, including Her Majesty's Revenue and Customs, the Department for Levelling Up, Housing and Communities, the Department for Business, Energy and Industrial Strategy and any other government departments as required.
