Subject: Corporate Business Plan Monitoring – Quarter 4 2014/15

Summary

The 'corporate business plan monitoring report' has been developed to demonstrate progress against the Council's Corporate Business Plan. This report contains information on the corporate performance monitoring undertaken during Q4 2014/15.

Recommendations

The Panel is asked to review and note the Council's Q4 2014/15 Corporate Business Plan Monitoring report.

1. Background

- 1.1 The Council's 'Corporate Business Plan' was adopted in November 2011 and sets out the Council's priorities for the period to the next local elections in 2015.
- 1.2 The Corporate Business Plan defines the outcomes or end results that the Council wants to achieve, and sets out the council's contribution towards these outcomes:
 - people benefit from a growing economy
 - people live in a quality environment
 - people maximise their potential
 - people lead safe and healthy lives
 - people live in thriving communities

The Plan also covers Council resources.

- 1.3 From the adoption of the plan, it was agreed that a report would be prepared quarterly, setting out progress against the work plan including details of any completed or new work key actions. The report is brought to the R&P Panel on Quarter's 2 and 4, however, all quarterly reports are available to Members on the Council's Intranet, 'Insite' (see the Performance Tab and click on Review and Report from the index on the left hand side).
- 1.4 The report contains an Executive Summary on the first page which provides an overview of progress against the six outcomes. The information in the body of the report provides further detail.

1.5 Members should note that outcomes which were completed prior to Q4 have been removed from the report and are contained in a separate archive report (the 'Corporate Monitoring Completed Actions Report') which is available to view on the 'performance' pages of Insite. Any outcomes indicated as now completed on the Q4 report will be removed from the next monitoring report and added to the archive report.

2.0 2014/15 Quarter 4 Performance

- 2.1 The 2014/15 Quarter 4 report, details progress with agreed actions. It is possible Members may be aware of more up-to-date progress with some actions this will be captured in the 2015/16 Quarter 1 report.
- 2.2 The Executive Summary for the 2014/15 Quarter 4 performance report indicates that key actions in the 6 outcome areas are progressing well and that performance is on track. 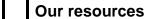

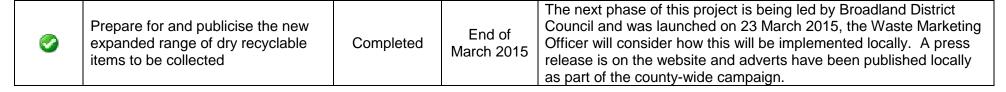
