Welcomed more competitive bus fares though BSIP (Measure 2.1) but thought bus operating times should be extended.</p> <p>Thought the AQAP should be more ambitious.</p> <p>Specific comments raised;</p> <p>M 2.1 BSIP; Bus services could be promoted better through improved information systems. The operating times on some routes could be extended (early / late).</p> <p>M 1.5 LCWIP; Concern over the implementation of LCWIP, plus the extent of secure cycle parking spaces in town centre. There needs to be better connectivity with the prioritised LCWIP routes in KL. Better promotion of walking.</p> <p>M 1.4 Travel Hubs; Active Travel Hub in South Lynn appears to be isolated; concern over the extent of mode shift secured.</p>
