The Monitoring Officer provided a verbal update on the changes announced in the Localism Bill laid before Parliament on 13 December 2010, which included the timetable for the Bill to gain Royal Assent and process for

implementation. Members were invited to take a copy of a briefing note the Monitoring Officer had prepared for information after the meeting.

In response to questions, the Monitoring Officer advised that the Localism Bill would give local authorities the general power of competence and would allow Councils to operate the committee system of governance, if they so wished. The Monitoring Officer added that the Standards Board would only form one element of the Localism Bill and would be considered as part of the debate. At present it was not known what the current standards regime would be replaced by, but it was anticipated that there would be some form of mechanism to monitor and maintain standards at local level.
