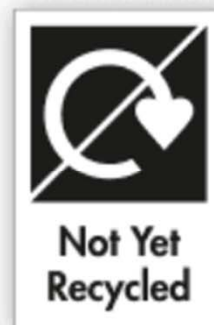
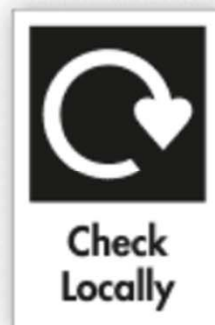
# The Green Dot Symbol

We are the UK Green Dot Licensing Company

European legislation places the responsibility for the recovery and recycling of packaging waste onto companies that handle packaging. Many European countries have adopted the Green Dot system - whereby obligated companies use the Green Dot symbol to prove they have complied with packaging waste legislation.

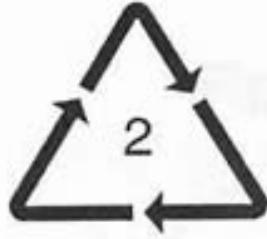


The Green Dot symbol **does not mean that the packaging it is applied to is recyclable**. It does not have any environmental or recycling meaning; therefore, should not be used to bolster an environmental claim. When looking for a suitable logo to promote environmental credentials or packaging recyclability there are a variety which can be considered. 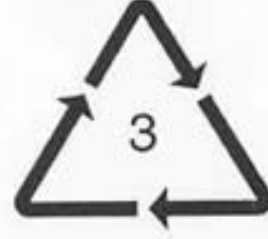

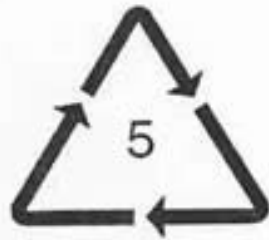

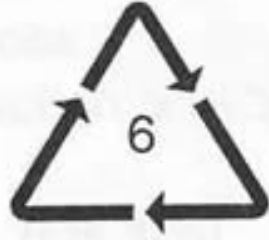
