Introduction

The Borough Council of King's Lynn & West Norfolk (the Council) is committed to restore and enhance biodiversity within West Norfolk.

Corporate strategy: 'To create a cleaner, greener, and better protected West Norfolk by considering environmental issues in all we do and by encouraging residents and businesses to do the same.'

What we are already doing:

Green Flag Initiative

The Green Flag Award scheme recognises and rewards well managed parks and green spaces, setting the benchmark standard for the management of recreational outdoor spaces across the United Kingdom and around the world.

Schools Climate Champion award scheme

How this project is different: (or what this project is adding):

The focus is on gardens, essentially 'a piece of ground, usually partly grassed and adjoining a private house, which may be used for growing flowers, fruit or vegetables, and as a place of recreation'.

As at April 2022: The top 3 land use groups in England were 'Agriculture' (63.1%), 'Forestry, open land and water' (20.1%), and 'Residential gardens' (4.9%)

About 87% of households in the UK have gardens, so there are getting on for 23 million gardens.

In West Norfolk, if we assume approx 60,000 households, that is 52,200 gardens.

For England, the garden area is more than four and a half times larger than that of our National Nature Reserves.

3 in 5 UK gardeners try to help their wildlife by feeding the birds, putting up nest boxes, or choosing to grow wildlife-friendly plants. We reckon there are about 7 million garden nest boxes, and in total we spend £200m every year on bird food. This augmentation of the resources birds can find in gardens has given a city like Sheffield six times the national bird density across the country as a whole!

The competition aims to

Reward residents for taking care of wildlife in their gardens Encourage civic participation towards achieving our corporate goals

Enhance wellbeing by bringing them closer to nature and green spaces*

Reduce loneliness*

Increase physical activity*

(*Thereby improving both physical and mental health)

Increase awareness of the critical nature of our biodiversity/wildlife (the UK is one of the most wildlife depleted countries in the developed world)

Educate people on steps they can take to help

Involve children to become active participants and hopefully, future leaders, in this effort

Celebrate our wonderful local wildlife

E&D assessment:

Inclusive of everyone regardless of protected characteristics Positive impact on people who have traditionally been excluded or stayed away from gardening /community initiatives

Method of submission / administration

Competition to be publicised widely - online, via social media, comms teams, and a paragraph on bins calendar.

Entries to be submitted

Online via website (to be created)

To be linked on borough council website and social media pages Paper entries- forms to be available at King's Court, public libraries, churches and other community locations- exact list tbc

Submission requirements

One entry form for each entry one entry permitted per household Tick boxes against criteria that the applicant has fulfilled

4 main categories: window boxes (WB), small garden (SG), large garden (LG), children under 14y of age(CH) (defined as 14^{th} birthday on or after 1^{st} of September 2025)

2 Special categories:

Longest Bee-line in the borough Best parish

Entries be submitted by 1^{st} August 2025 - each entry to be accompanied by a maximum of two photographs.

Entry Evaluation

A successful entrant will be the submission that offers the most ecologically advantageous features. This will be evaluated on the basis of the following criteria as laid out on the entry form:

Criteria:

- Use peat-free compost
- Avoid use of herbicides/pesticides/insecticides
- Wildlife-friendly water feature

- Recycled Container/s
- Native wildflowers and grasses with signs such as 'Bee friendly!' or 'Let them Be(e)!", 'Pardon Our Weeds, We're Feeding the Bees', 'Bee-Hotel', 'Pollinator Garden' etc https://www.shutterstock.com/image-vector/bee-kind-spread-kindness-positivity-vector-2547374611
- Insect Hotel
- Climbing plant/s e.g. Ivy or Honeysuckle
- Wildlife-friendly plants including pollinator plants such as sunflowers, in clumps, borders, hedges etc

- Log Pile
- A home for Nature e.g. Hedgehog Hotel/Bird box/Swift box/Bat box
- Hedgehog Access
- Compost Heap
- Native Hedge or Vertical Garden
- Nature-friendly Pond (LG) or small water feature
- A Fruit Tree/s
- A Wild Patch that includes Nettles and signs (see above)
- Native Shrubs and Trees

Imagine trying to travel around the UK without our road and rail network. Or imagine if nine out of every ten miles of road just didn't exist - life would be impossible! That is the situation faced by our vital pollinators and other bugs.

Winner Award / how competition will be judged

Based on number of criteria fulfilled

If multiple entries are found eligible in any category, final shortlist to be decided by judging panel

Final shortlist gardens will be visited by the judging panel 1 Gold, 2 Silver and 3 Bronze awards in each category, (so 4 Gold, 8 Silver and 12 Bronze) plus one lucky winner, plus 2 special category awards, so 27 awards in total (exact number of awards tbc, depending on sponsors)

All children will get a participation prize (golden pine-cone and a certificate)

Prizes to be sourced from garden centres/interested businesses/organisations

Men's Shed, Forward and Futures, MIND, Churches Together and other volunteer groups to be asked to be involved in making bird boxes, Garden signs, plaques etc

NVN have agreed to be a resource hub

The Borough Council of King's Lynn and West Norfolk (the Council) is seeking a project that promotes awareness of biodiversity loss and action to reverse it in the community.

Project Aims: -

- Promote biodiversity within West Norfolk.
- Enable entrants to understand the following: -
 - What is biodiversity
 - What actions they can take to help improve biodiversity in their gardens.

Proposed timeline of works:

- Finalise details of project- January 2025
- Set up website and finalise all comms materials- end Jan 2025
- Wording to be added to bin calendars Jan 25
- Information about competition via bin calendars distributed to each household - ?March 2025
- Forms and website links to be made available March 2025
- Links to resources to help people to go live March 25
- Find sponsors of awards- Feb-April 2025
- Agree judging panel: April 2025
- Entries to come in May-July 2025
- Judging- August 2025?
- Award ceremony- to be tied into mayor's awards ceremony for WN (tbc)

The below bullet points summarise what a successful competition would look like: -

- Hundreds of entries online and on paper format from all of WN, and especially children
- Queries to be answered promptly and help made available when required (NVN)
- Judging to take place on time
- Well-publicised and well-attended Awards ceremony
- Competition to continue every year with the goal of nearuniversal participation in coming years and everyone feeling enthusiastic about supporting our precious wildlife
- West Norfolk to gain national (and international) recognition as the place to go to see, study and enjoy wildlife! Improved tourist numbers, educational resources, awareness

Large Garden(LG): anything larger than a small garden

Child under 14y (CH): 14th birthday on or after 1st September 2025

Window-box (WB): includes potted plants on paved patios, window sills, front or back porch

Tick all the boxes for the criteria (see list below) that your garden fulfils.

Please do not worry if you don't tick all the criteria - every garden entry is valuable, and we have separate standards for different gardens.

Every entry is entered into a lucky prize, and could help your parish win best parish award

The expected features for each type of garden are labelled against each line.
