Decision Taken

West Norfolk has one of the largest settled Ukrainian and Eastern European communities in Norfolk. In view of the worsening situation in Ukraine it is reasonably expected that people will be fleeing their homes in Ukraine to join their families here in West Norfolk or come here to settle in a community that can support them.

In the immediate days of arriving in West Norfolk, and before wider statutory and emerging support arrangements can be put in place, some of these refugees may experience immediate financial hardship. It is proposed to introduce an emergency support grant scheme, administered by the borough's LILY team to mitigate this. The scheme to operate as follows:

- Self or third-party referral into Borough Council Via CIC or from Access Migrant Support/Hanseatic Union/Housing Options via telephone or the completion of an online referral form
- Form received into Lily service
- Client contacted (use of language line if necessary additional resourcing being arranged)
- Triage / Exploration of needs
- Immediate emergency support provided by borough council if needed (such as food/shopping vouchers/utilities support and guidance) to cover any lag in wider statutory services wrap around
- Signposting and referral to other local and regional services and support

Given the serious and rapidly escalating situation, with refugees already en route, It is considered the council needs to act promptly and compassionately to have such a scheme in place for their arrival in West Norfolk. Whilst we do not know the number of people who will choose to come to West Norfolk, it is proposed to allocate initial funding of £7,500 from the West Norfolk Wins local lottery reserve for this purpose and to review as the situation and demand becomes clearer. The reserve currently has an uncommitted balance of £19,000.

Reasons for the Decision

To provide emergency support for Ukrainian refugees who arrive in West Norfolk. In the immediate days of arriving in West Norfolk, and before wider support arrangements can be put in place, some refugees may experience immediate financial hardship. It is proposed to introduce an emergency support grant scheme, administered by the borough's LILY team, who are experienced in supporting residents in need, as demonstrated throughout the Covid pandemic.
