#### **Decision Taken**

A range of global and national factors, including coming out of the pandemic and the war in Ukraine has resulted in volatility and significant rises in individual prices, inflation and the cost of living.

The rising cost of living will have an impact on the poorest households in our communities as they have to spend far more of their household budgets on utilities. We anticipate that the demand on the food banks in west Norfolk will increase, particularly as we move into the autumn and winter months and the pressure on household budgets increases from the need to spend a higher proportion of their limited income on heat and light.

The Borough Council will allocate a ringfenced sum of £15,000 to support west Norfolk food banks. This funding to be drawn down on request of the food banks to purchase food supplies. £10,000 of the funding to be allocated to the King's Lynn food bank and £5,000 for Hunstanton and Downham Market food banks.

The funding can be met from the uncommitted balance on the financial assistance reserve.
