Financial Assistance Small Grants Scheme

Summary

Reason for Decision

Awards over £5,000:

Barton Bendish Village Hall Trust

Funds are requested towards a refurbishment and extension of Barton Bendish Village Hall.

The planned works will include new flooring, doors, windows, kitchen, and heating system, as well as installation of insulation, re-roofing, redecoration and the requirements for the extension. It is explained this will repair the current problems with the village hall for current groups, make the hall more accessible, as well as improve facilities to attract new user groups and enable larger functions in a more sizable hall space.

The works will cost a total of £275,710, and over £150,000 has been secured to date.

Decision: To award £10,000 on the condition that the full funding needed to proceed is secured.

Snettisham Memorial Village Hall, Pavilion & Playing Field

Funds are requested toward a major refurbishment and extension of the sports pavilion at Snettisham.

The current pavilion was originally designed to cater for men only, and does not have suitable facilities for women or children. The planned extension will house suitable showering and changing facilities for all genders and age groups. These will enable the pavilion to properly cater for the sports teams regularly using the premises, including Snettisham Senior and Junior Football clubs, Snettisham Cricket Club, King's Lynn Walking Group, and Top Tennis Coaching.

The recreational area will also be refurbished to include new toilets, a new kitchen, new heating and hot water system, disabled entrance, new doors, windows, redecoration, new floor, complete rewire and fitting of new lights and electrics, solar panels, security shutters and storage for the village events committee.

The works will cost £214,952 in total, of which £204,840 has been secured.

Decision: To award £10,000 to complete the funds needed to undertake these works.

The Garage Trust Ltd

Funds are requested towards portable studio equipment for The Garage's new premises in King's Lynn.

Based in a space on New Conduit Street for the first year, The Workshop will host small-scale, professional arts performances and a participation programme to engage disadvantaged young people in the cultural arts. In practise, the ambition is to hold up to 150 performances per year with an audience capacity of 60-100, and run up to 65 weekly classes per term in dance, drama and dance to a full range of age groups. The application explains that 60 free places will be offered in the dance, drama or music classes for children and young people referred by other agencies.

This venue is temporary while a permanent site is sought, and equipment purchased at this stage will be portable and able to be moved to a new venue.

Items costing £25,500 are required to equip the venue.

Decision: To award £8,000 towards equipment to enable immediate programmes, and to be able to be moved to a permanent venue in the future.
