

Consideration of revised version of the Local Plan Review document and associated material

Note by Planning Policy Manager

Background

Members will recall that the Task Group has been considering the responses to the Draft Plan consultation (March 2019), and related matters since around July 2019. Progress was reviewed at the last meeting on 1 July, and a revised approach agreed. Officers have been working up a complete revised version of the Local Plan Review document incorporating work done by the Task Group to date and proposals for changes on policies and text not previously considered. This work has been done in the light of the comments made in March 2019 and the revised Sustainability Appraisal assessments. An additional very important consideration has been the changes to housing numbers from Government. This was covered at the last meeting. This has caused significant changes within the Plan from the Consultation version.

The version presented for this meeting

To help Members navigate the documents and information provided with the agenda I have given below a list of items and as necessary comments as to how they relate to the Plan.

1. **Local Plan Review Document July 2020** – This is the re-worked version incorporating the changes previously agreed by Task Groups and also proposed changes from Officers. (There are one or two items marked as ‘to follow’, but this will be explained as those sections are covered).
2. **Consultation comments and responses** – We have attached the comments made ordered into the sections of the Plan, and then the individual policies and comments made about them. The responses column will contain any proposed changes if appropriate, which will have been incorporated into the text of 1. above. In addition, for each policy the proposed changed text / policy wording will be highlighted. Where one organisation has submitted a large number of comments, such as Environment Agency, a separate list of comments and responses specific to them has been prepared and labelled as such.
3. **Sustainability Appraisal assessments** – This folder contain the SA scorings and discussion. It is split into policies and settlements. It follows the order of the Plan.

Therefore, Members can consider the comments made and the proposed responses, cross referencing this to a revised scoring from the SA and appreciating this in context of the whole Plan when reading the full document.

Because of the changes made you will find the policy numbers in the Plan have changed. So, when accessing particular policies or responses you can check what previous numbering was from the schedule (Appendix 1) attached to this note.

I referred above to the Task Group having considered policy wordings, responses etc at previous meetings. In order to help Members to focus on items not previously discussed. The Appendix has a column indicating where Members concluded they were previously content with the wordings / approaches put forward.

Recommendation

As for previous meetings Members will be asked to indicate agreement or otherwise or propose amendments to individual policies or text in the light of the background documents or other relevant considerations.
