<b>Project Details - Project Name/Title</b>	Bus shelter for school children Silt Road, Nordelph
<b>Name of Organisation submitting this request</b>	Nordelph Parish Council
<b>Project description - Brief description of the project:</b>	The aim is to provide a much-needed bus shelter for the children of Nordelph at drop-off and pick up times. For years our children have stood in all weathers on a very exposed, wide-open section of Silt Road to wait for their transport and the Parish Council would like to rectify this. Please understand small parish councils like Nordelph with a very small precept just can't afford this type of project without financial support from such funds as this. The village has limited services and facilities and a bus shelter would make such a difference. I have noted that other larger parishes with more financial resources have benefitted from funding for a bus shelter from the Cil fund; it would be great if some of the smaller parishes in your borough without these extra financial resources could also benefit.
<b>Match Funding</b>	There are no surplus funds from the annual precept of just £9,500.00 to allocate to this type of project; it would equate to 50% of the precept which is just not viable for a small parish like Nordelph.
<b>Summary of Expenditure</b>	quote of £4,155 + Vat to provide and install a 2-bay reverse cantilever shelter
<b>Community Benefit</b>	The community of Nordelph has limited resources / facilities, if any. The installation of a bus shelter would make SUCH a difference to this small community. It might not benefit as many residents as a bus shelter does in some of your larger parishes but without financial assistance from funding pots such as this your smaller communities never have a chance of improving their facilities / services for their residents. This type of funding is vital and integral to improving the lives of the people in rural areas that miss out on so many opportunities because of the size of their parish.
<b>Local Support</b>	I have been Clerk for Nordelph for 12 years and the issue of a bus shelter for the school children has been on-going since before I joined. Our Ward Councillor has always championed our efforts to try and achieve this goal for the parish and is fully supportive of our goal.
<b>Project timescale</b>	This project can be progressed immediately. We have permission from NCC Highways to proceed and Westcotec Ltd. are fully on-board.

<b>Project Details - Project Name/Title</b>	20mph speed limit around our village school
<b>Name of Organisation submitting this request</b>	Marshland St James Parish Council
<b>Project description - Brief description of the project:</b>	The speed limit in Marshland St James is to be reduced from 40mph to 30mph. We wish to add further school-time restrictions by introducing 20mph zones on Smeeth Road, Walton Road and School Road around the crossroads that link those streets. This will involve four 'wig-wag' flashing warning signs and associated road signage.
<b>Match Funding</b>	Funding from CIL Parish Payments (£5500) and Funding from Parish Precept (£3000)
<b>Summary of Expenditure</b>	We have been advised by Highways that 'the indicative costs are in the region of £6054 a pair plus £1000 commuted sum for maintenance this also depends on electrical feed or solar powered etc etc, we are seeing a monthly increase in costs though so I would suggest adding on 20%.' That would equate to £16929 in July 2022. Work would be commenced as soon as it can be programmed following a funding decision.
<b>Community Benefit</b>	Marshland St James school is located on a narrow congested road, close to a busy road junction and with limited parking. Provision of 20mph school-time restrictions will enhance the safety of the area.
<b>Local Support</b>	The scheme is supported by the Parish Council, our District Councillor and our County Councillor. We carried out a consultation for our putative Neighbourhood Plan earlier this year and excess speed was raised as an issue of concern by many respondents.
<b>Project timescale</b>	Commencement in Autumn 2022 with completion by the end of the year

<b>Project Details - Project Name/Title</b>	Refurbishment of Landing Stage, Church Bridge Mooring, Upwell
<b>Name of Organisation submitting this request</b>	Well Creek Trust Limited
<b>Project description - Brief description of the project:</b>	The project plan is to refurbish the mooring after many years of wear and tear due to its popularity with boaters, fishermen and the local residents of the surrounding villages. The Upwell Parish Council, along with Kings Lynn and West Norfolk Borough Councillors, the Middle Level Commissioners and the Blunt Trust are fully in favour of the work.
<b>Match Funding</b>	The Blunt Family Trust in Upwell, has kindly agreed to partially fund the project with £13,000.00. Even though the quote is for £ 26, 474.88, we have applied for £15k due to the volatile cost of wood and to compensate for inflation.
<b>Summary of Expenditure</b>	The Well Creek Trust has received a quote for £26,474.88 from a local reputable builder , who has a lot of experience with this sort of work. The work should only take 4 weeks to complete.
<b>Community Benefit</b>	The Church Bridge mooring was originally built in the 1980s and over the years, due to its popularity with the boaters, was extended in 2007 to its present length of 52.4 M. At many times during the boating season from April to October, the mooring is often full with NarrowBoats and Cruisers and even doubled moored. The boats usually stay overnight, where the visitors use the local village amenities. The landing stage is popular with the local fishermen and is used by the residents, where they rest and watch the wildlife and boats. Finally, the refurbishment further supports the Upwell Neighbourhood Plan, where the Creek is mentioned as a high quality tourism attraction (5.2) Economy and Tourism Policies and Community Actions.
<b>Local Support</b>	The Well Creek Trust has received emails of support from the chairman of the Upwell Parish Council, 2 local Borough Councillors of the BCKLWN and the Blunt Trust. The Well Creek Trust also received further support from its members.
<b>Project timescale</b>	The work should only take 4 weeks and the project plan is to start in the first week of November 2022 and complete it by the 1st December2022.

<b>Project description - Brief description of the project:</b>	A new porch for the village hall is seen as part of the continuous improvements that the Village Hall Committee are trying to do.
<b>Match Funding</b>	Between the village hall and the North Wootton Parish Council we will be putting in the extra £7000, as our contribution to the funding.
<b>Summary of Expenditure</b>	We have 3 Quotes from local builders to carry out the work.
<b>Community Benefit</b>	<p>We believe that putting a porch on the front door will increase the rentability of the hall.</p> <p>Compliment the aesthetics and general look of the building.</p> <p>Improve access in and out of the front entrance by disabled users</p> <p>Bring in a diverse group of people that do not use the hall at the present time due to access issues</p> <p>Continue the improvement of the hall as a Community Centre for the village</p>

<b>Project Details - Project Name/Title</b>	Surface matting visitor car park
<b>Name of Organisation submitting this request</b>	Castle Acre Parish Council
<b>Project description - Brief description of the project:</b>	Castle Acre's Neighbourhood Plan calls for a dedicated seasonal visitor car park to draw incoming motorists away from the centre of the village. The Plan was approved by 88% of those voting and is now official policy. Objective 8 calls for designated 'off street' parking to improve pedestrian safety and to reduce the visual dominance and physical impact of parking in the village centre.' CAPC will rent Holkham's grass field off Priory Lane on a long-term lease of £200 pa (see uploaded images 4 & 5, map and parking layout). The field is within the Conservation Area. To protect its 1,200 m2 grass surface from damage by up to 40 parked cars per day, CAPC plans to install a tile system, supplied by Gridforce - made of 100% recycled low density polyethylene plastic, frost and UV radiation proof. It will provide a stable, eco-friendly reinforcement laid within the surface grass. See uploaded project plan for full details.
<b>Match Funding</b>	£10,000 Lottery Awards For All £2,000 CAPC own CIL funds  (Actual £1,620.04 - FY21/22 Parish Report) £2,000 CAPC reserves
<b>Summary of Expenditure</b>	The total cost of the surface matting, including laying and labour, is £24,700 + VAT (quote uploaded). CAPC can reclaim VAT
<b>Community Benefit</b>	By encouraging motorists, through both signage and limiting on-street parking, to use the new visitor car park, it will reduce the number of parked cars in the village centre. Such an infrastructure development will have the advantage of creating and maintaining a positive difference to people's lives in maintaining accessible, clean, pleasant and safer public places and communities (CIL project criteria – community facilities). It will have direct environmental benefits by reducing traffic, parking, noise and pollution in the village centre, thereby improving the well-being of residents. It will be safer for residents and visitors alike strolling around Stocks Green, using the pub and café. It will make this conservation village and its surrounding countryside a more enjoyable and less stress-free experience for the many annual tourists – meeting the CIL economic criteria of supporting Castle Acre as a leading visitor and cultural destination
<b>Local Support</b>	The questionnaire issued to residents as part of the village's Neighbourhood Plan generated many calls for a solution to over-parking in the village centre. Objective 8 in Traffic & Transport calls for 'Management of 'on road' car parking in the centre of the village to reduce congestion and to allow permitted traffic to pass through the village safely. Provide designated 'off street' parking to improve pedestrian safety and to reduce the visual dominance and physical impact of parking in the village centre.' CAPC and residents support this new Visitor Car Park as a significant benefit to this Conservation village.
<b>Project timescale</b>	It is expected to lay down the matting in early Spring 2023 and open the visitor car park in May 2023 in time for increasing visitor numbers

<b>Project Details - Project Name/Title</b>	Solar/Heating/Air Conditioning Project
<b>Name of Organisation submitting this request</b>	Sedgeford Parish Council
<b>Project description - Brief description of the project:</b>	Currently, Sedgeford village hall's electrical supply is via the national grid and our heating is by way of oil-fired boiler/radiators. We plan to fit solar panels to the roof of the hall, to reduce our dependence on the national grid for our electricity and reduce ongoing costs. At the same time we plan to fit electric heating units to replace the current oil-fired radiators, that will also provide air conditioning in the hot summer months when the hall can be unbearably hot. Both measures will reduce the hall's carbon footprint.
<b>Match Funding</b>	Parish Council (Precept)- £2500 Village Hall Committee -£2500
<b>Summary of Expenditure</b>	For full details of the solar and heating/air conditioning please see the quotes and plans attached.  Solar installation- £14482, Heating/Air Conditioning installation - £14328, Total Cost - £28810  The plan is to build in resilience, so the hall becomes a "command" hub in case of a local disaster involving the loss of electrical power. Two batteries would be installed to store energy from the solar panels, and this would provide power for lights and sockets for a significant period at the command hub, with emergency heating via the existing oil boiler/radiators. This would enable potential rescue communications to be housed at the hall, together with possible emergency accommodation for villagers. The two batteries will be topped up daily, via cheap overnight tariffs, on days when there is insufficient sun.
<b>Community Benefit</b>	The Village Hall is a well-used community infrastructure facility. This project provides an environmental boost to the village, demonstrating the desire of the Parish Council and Village Hall Committee to contribute towards an improved environment by reducing the use of fossil fuels. Locals will be encouraged to follow suit by the solar contactor hosting a demonstration evening. By utilising solar technology we will greatly reduce the ongoing cost of our electricity for the hall. By reducing our dependence on the oil-fired boiler to almost nil, we will avoid the vagaries of the oil market prices. The whole project will ultimately allow the Village Hall Committee to consider other community projects with its improved budget.  Not only will this project benefit the village, it will also contribute towards Borough, County and National Government environmental targets.  The many locals who use the hall facilities, will benefit from the knowledge that the hall is being future-proofed.
<b>Local Support</b>	This application is made by the Parish Council, with the support of the Village Hall Committee. Parishioners are becoming increasing more

	environmentally aware and are extremely supportive of the plan. Regular users the Arts Society, table tennis, dance, keep fit and stretch/relaxation groups have all voiced support.
<b>Project timescale</b>	The project would commence immediately funding is agreed and would be completed within 2-3 months

<b>Project Details - Project Name/Title</b>	Replacement External Fire Doors
<b>Name of Organisation submitting this request</b>	Sedgeford Parish Council
<b>Project description - Brief description of the project:</b>	Sedgeford Village Hall was built in 2000 and the original doors are showing signs of age. There are three sets of double fire doors and one single. A number of the glazed units are “blown” impacting on their ability to insulate the building. All door frames have become misshapen, again adversely effecting insulation performance. The “push bar” opening mechanisms are all very worn, making building security an issue. Often doors appear to have closed properly, and the alarm set, but they can be opened from the outside.
<b>Match Funding</b>	Parish Council (From Precept)- £1000 Village Hall Committee -£1000
<b>Summary of Expenditure</b>	The price for the French door's with side panels and push bar would be: £2,760.00 inclusive of Vat and Fitting. Single door: £1,440.00 French doors with no side panels: £2,040.00 each. Total for both: £4,080.00 The total price for everything would be: £8,280.00
<b>Community Benefit</b>	The Village Hall is a well-used community infrastructure facility and is used by a variety of parishioners and visitors. Difficulties locking these doors impacts on all users, as does any exposure to the elements through the doors lack of insulation. The security of the hall is vital to protect its contents and the fabrication of the building. <b>Project Details - Project Name/Title</b>	Fencing for Playing Field - Brancaster
<b>Name of Organisation submitting this request</b>	Brancaster Parish Council
<b>Project description - Brief description of the project:</b>	The Playing Field is at the rear of the Brancaster Village Hall/Club 71/shop complex - an old fence is starting to collapse. It is an important safety measure separating the car park from the children's play area, immediately adjacent. Recently the club has been greatly developed, and the shop has become much busier - more local shopping. This has increased the variety of goods provided, and, although it may be apocryphal, the customer base has increased primarily among new residents, from the considerable increase in new homes. This has also increased the number using the playing field and play area. Additionally, more events have required us to use a small area of the field for extra parking - this requires a change in the location of, and a stronger, gate for such access. Finally, UKPN will be completing their sub-station plans and we wish to tie the new fence into that. The fence is to be mainly/completely of recycled materials, for environmental and maintenance reasons.
<b>Match Funding</b>	PC to make up remainder from CIL/reserves. Community Fund UKPN being approached due to proximity of the sub-station which is behind current fence
<b>Summary of Expenditure</b>	The cost was quoted at £4,100 a few months back for materials only. We are looking to have it fitted by the supplier, and know the cost will have increased, almost certainly totalling £7,372.33 - quotes are currently being sought. We seek 50% of that figure. The remainder will be funded by the PC, using CIL and/or reserves. We have also applied to UKPN for some money from their community fund, which will reduce this portion.
<b>Community Benefit</b>	The sports club/village hall complex is very well used by locals. It is a shared facility with many different roles, and there needs to be clear and safe division between those aspects. The use of this area is shared between all ages and demographics. A new fence would remove the need for continuous maintenance and patching etc. of the current provision, which has its own cost.

<b>Name of Organisation submitting this request</b>	Upwell Parish Council
<b>Project description - Brief description of the project:</b>	The existing heating system is approx.: 20+ years old and has been repaired on a number of occasions. It is on its last legs I believe and may not last the winter out this year. The existing system is an Oil-fired boiler running through antiquated steel barrel pipework. The inefficiency of this system is unmeasurable. <b>Project description - Brief description of the project:</b>	<p>We currently have a set of 30 PV solar panels on our kennel block and we want to double this and add battery storage, to enable us to use all the electricity we generate rather than sell it back to the grid; at a miserly price! At the same time we want to replace the inverter on our current panels and install batteries (can't install the batteries with the current inverter) on these so that we can save and use that electricity for ourselves as well. The total cost for the project is approx. £23,000.</p> <p>We are in a contract for our electricity which ends in the next few months and the cost will increase dramatically – at least £8,000 per annum. It's not only the cost, we are looking to go carbon neutral next year.</p>
<b>Match Funding</b>	We ran a Crowdfunding campaign supported by Aviva that ended two weeks ago and that raised £13,287, which is fantastic so we are just looking to raise the balance from CIL.
<b>Summary of Expenditure</b>	All work will be carried by the local company; A8kw solar array with 20kwh Battery Storage: 15,180 Replacement Invertor 5760 Electrical works to site : 2,380 Total 23,320
<b>Community Benefit</b>	We are currently facing an increase in our electricity costs of a minimum of £8,000 and maybe more. This branch takes in and rehomes animals only from local area, whether they be from people who can no longer look after them or if they cannot afford vet bills etc. We also supplied last year almost 400 vouchers towards vet bills for families in the local area, this is something that we are going to have to consider restricting if we can not reduce our fixed costs. By alleviating any increase on electrical costs this free's up cash to spend in the community. Also, our diesel van is now costing £120 to fill up and we plan to replace this with an electric van and coupled with the new solar panels this will give us almost free motoring... Again saving money we can put to use in much better ways.

<b>Name of Organisation submitting this request</b>	Nordelph Village Hall
<b>Project description - Brief description of the project:</b>	The new Nordelph Village Hall Committee would like to bring Nordelph, and the surrounding areas, back to their former glory. Prior to the pandemic, the Village Hall was the "heart of the community" (hence the project name) and we would like to restore the feeling of togetherness and community. Unfortunately, lockdown and changes in committee members has meant that the hall needs extensive repairs, including damp-proofing, replacement disabled facilities, heating, updated lighting and a replacement kitchen after the damp has been sorted. This will provide us with the facilities to bring the Village Hall back to being 'The Heart of Nordelph'.

<b>Community Benefit</b>	<p>Our project will ensure that all local residents, whatever age or situation, feel like they are part of a wider family and feel supported by the Committee and the village community itself. We have a large number of elderly people and families that are struggling financially and we would like to create a place and a feeling that they can all be part of, where they have events and activities they can be a part of. This project is an ongoing venture, however we have a lot of repair works, garden development and refurbishments that need to be done, due to the building being left unused for the period of the pandemic. Nordelph is a small village that does not have any facilities locally, other than the Village Hall. <b>Project Details - Project Name/Title</b>	Accessible Facilities and Toilet Upgrade
<b>Name of Organisation submitting this request</b>	Fincham Memorial Hall and Playing Fields
<b>Project description - Brief description of the project:</b>	The toilets in Fincham Memorial Hall have not been updated since the original build in the 1950's. As such they are in a sorry state of repair and far from meeting the needs of an ageing community. The project aims to update them to not only current standards, in term of both hygiene and the environment but also the inclusion of a disabled and easy access cubical. With the hall actively used by the community and acting as a hub of village activities these upgrades are crucial. In the current Covid era, it is unacceptable to have no hot water, no hand dryers and the wider facilities are in a debilitated state and barely flush. We have consulted hall users for their views, including those who no longer use the hall due to the state of the toilets (attached in additional info). Architect's plans are in place, quotes obtained and companies ready to start work on the project, all we need are the funds, of which we have raised a significant proportion already.

<b>Summary of Expenditure</b>	We have engaged Void architects to work with us to draw up plans on adjustments needed to make provision for a fully accessible unisex disabled toilet with baby change facilities. We have invited local contractors to provide quotations based on these plans, to deliver the full programme of works as per the architectural drawings. Full quotes, breakdown of costings and detailed information is provided in our supporting documents. The average of the two quotes is £44,225 (inc VAT), and contingency has been applied to give a total project estimate of £49,533. The quotes are based on the required new disabled toilet facilities, provision of hot water, lighting and heating, new installation of facilities for the mens and women's toilets, hand drying provisions, mirrors, new flooring, tiling and new waste routes and external drainage. We aim to complete the works by December 2022.
<b>Community Benefit</b>	Fincham has an aging population and with it the needs of the hall are changing. 57% of the population is over 50, 34% over 65 and 23% over 70 – there is very little public transport and many do not or cannot drive. Some are carer's, some are mobility-impaired or disabled. The only social events in the village take place at the village hall, but with inadequate facilities which directly discriminate against those who are not able-bodied, the hall is not welcoming nor fully inclusive. Every single hall user would benefit from this programme of works, including those who have had to stop visiting the hall due to the lack of disabled facilities. In turn this would greatly help in reducing rural and social isolation, especially for the elderly which, as lockdown has shown, can

	be a lifeline. The need for this space is evident from the heavy use and range of activities taking place there, but the toilets desperately need to be brought up to modern standards, which requires funds.
<b>Local Support</b>	We have sent out a survey to hall hirers from the past year representing 16 regular local community groups and private individual hirers (who in turn represent the views of over 300 hall users) with 100% of respondents noting that there is a need to upgrade the facilities. We have uploaded detailed feedback in our supporting documentation, including free text contributions which clearly demonstrate the need, support and the tremendous difference it would make to a huge number of people if this project was funded. Although the toilets do function (for able bodied users only), they are somewhat unreliable and not pleasant to use, as is evident from the written responses. It is a 'talking point' but not in a good way, amongst the users of the hall. Various letters of support are also included in the appendix, including from the Parish Council which meets in the hall and is 100% supportive of this project and has offered a financial contribution (along with others) to support the project.

<b>Project Details - Project Name/Title</b>	Trod to link Wimbotsham and Stow Bridge
<b>Name of Organisation submitting this request</b>	Wimbotsham Parish Council and Stow Bardolph Parish Council
<b>Project description - Brief description of the project:</b>	This Proposal is for a Trod/footpath: A Trod from Wimbotsham village to end opposite the butchers in Stowbridge. Planning permission has been granted for 240 homes, reserved matters ref 21/01121/RM, a large number of which will fall within Wimbotsham Parish. However, Wimbotsham Parish Council will not be eligible for any CIL funding for this development. Stowbridge Parish has also had a significant number of properties built, which are exempt from CIL payments. The Parish Council's believe both parishes would benefit hugely from CIL funding to support the village infrastructure and would like to apply for a grant to provide a safe pedestrian link between the two villages.
<b>Match Funding</b>	<p>The estimated total cost for the project would be £30200.</p> <p>Wimbotsham Parish Council have pledged £6342.00 towards the project, which is 21%.</p> <p>Stow Bardolph Parish Council have been unable to commit any funds to this project at present due to other commitments, but it is hoped that the Trod could be extended to run to Landymores in the future and it is anticipated that Stow Bardolph Parish Council could make a contribution towards that.</p> <p>County Councillor Brian Long has offered his full support to the project and has offered a contribution of £2000 towards the project, which is just under 7%.</p> <p>Therefore, the Parish Councils are asking for a Total Grant Request of £21,858.00</p>
<b>Summary of Expenditure</b>	<p>Both Parish Councils met with Local Highways Officer for Norfolk County Council, to discuss the proposal and he supports this and has provided quotes for the work. Both our Borough Councillors and County Councillor support this application and acknowledge its benefits.</p> <p>Estimated costs:</p> <p>The quote for the most basic 1m wide, no edging, no surfacing basically sub base on a geotextile would be £30200 if you would like it surfaced with Surface dressing it would be £45200 this is from Wimbotsham to junction by Sargeants.</p> <p>The Parish Council feel that the basic surface would be sufficient, and this is what has been used for the other Trods in the village.</p> <p>The estimated total cost for the project would be £30200.</p>
<b>Community Benefit</b>	The stretch of road where the proposed Trod would be has a 60mph speed limit. The grass verges, where they exist, are uneven and often overgrown with weeds, so pedestrians have no choice but to walk on the road. Extending the footpath along this section of road will directly improve road safety for residents and have a positive impact for both parishes. As well as providing a safe pedestrian link between the two villages, it will encourage parishioners to walk to the businesses in each. It will encourage more pedestrian use of this road; therefore, this project would make a contribution to reducing air pollution.

	<p>Evidence suggests there are 5 steps everyone can take to improve health and wellbeing and this project will help to contribute to all of those steps by offering the opportunity to be physically active, connect with others, learn new skills, give to others (through joining in community activities), and by being mindful (by being outdoors and noticing the world around them).</p>
<b>Local Support</b>	<p>The Parish Council's both receive frequent communication from residents who are concerned about road safety in the village.</p> <p>The Wimbotsham Parish Plan, which had a 82% response rate from parishioners in the consultation, stated: 'Use of the public footpaths around the village is high with 69% of respondents saying they use them. This high use is reflected in the strong support for safer walking routes in and out of the village.' This proposal would improve the footpaths network and encourage walking.</p> <p>One of the six main priorities of Norfolk's 3rd Local Transport Plan is improving accessibility and this proposal would also support this aim.</p> <p>Wimbotsham PC wrote an article in the Parish Newsletter outlining this proposal and received overwhelming support with 27 emails of support, the main priority being a safer route between the two villages.</p>
<b>Project timescale</b>	<p>We would like this to be completed as soon as possible and would like to see it completed within the next six months.</p>

<b>Project description - Brief description of the project:</b>	The installation of two child safety gates for the entrances to the Play Area and the installation of safety surfacing under the Flat Swings, Slide, Multiplay Unit, Cableway and Springers at the Play Area at Runcton Holme Parish Council Play Area.
<b>Match Funding</b>	<p>The Parish Council will allocate 25% of the project costs, excluding VAT = £4101.00.</p> <p>The Parish Council have explored other funding options, including contacting NCF, but there are no grants of this type available.</p>
<b>Summary of Expenditure</b>	The Parish have contacted three companies



	Total Project Costs: £16404, exc VAT.
<b>Community Benefit</b>	<p>The Play Area is a well used facility and is close to the village School which also serves other villages. Wormegay CofE Primary School was recently amalgamated with Runcton Holme CofE Primary School.</p> <p>The installation of the safety gates is needed to prevent children running out onto the road and into the car park. This was highlighted after some recent incidents with young children exiting the Play Area.</p> <p>The safety surfacing is an important safety feature and has been highlighted on our annual play inspection reports for several years, but the cost has been prohibitive.</p>
<b>Local Support</b>	<p>The Parish Council own the Play Area and are submitting this application.</p> <p>The Social Club Committee, who run the Social Club on the site support this application. Whilst we acknowledge the need to maintain and upgrade for safety, we are a small parish with limited funds. There is local support from users of the Play Area.</p> <p>Our Borough Councillor Mike Howland also supports this application and made the following comment: 'I understand the Parish Council are applying for a Community Infrastructure Levey Grant at their Recreation Ground for safety surfacing under the play area, and for two much needed safety gates.</p> <p>I believe this matter was highlighted at their recent play area inspection, but the cost was prohibited, I am therefore happy to support their application as it will benefit the children who use the play equipment and make the area safer for the children to use'.</p>
