# **Update Report to Planning Committee – 6 March 2023**

Proposal:	Plans to develop a new Energy from Waste (EfW) Combined Heat and Power (CHP) facility generating electricity and steam, (and associated grid connections) on land at Algores Way, Wisbech.
Location:	Wisbech, Cambridgeshire, with associated grid connections in west Norfolk.
Applicant:	Medworth CHP Ltd
Case Officer:	Lorna Gilbert – Principal Planner

#### **SUMMARY**

This is an update on the Medworth Development Consent Order that was submitted to the Planning Inspectorate in July 2022, for a new energy from waste plant in Wisbech. The plant is located within Fenland District Council and Cambridgeshire County Council's area, with the underground cabling connecting to a substation in Norfolk. The application is being assessed by the Planning Inspectorate who are the Examining Authority, and are assessing it on behalf of the Secretary of State. It is a nationally significant infrastructure project, so is going through an Examination process in accordance with strict procedural guidelines. This process has a number of deadlines and timescales to meet, and is due to conclude in August 2023.

The preliminary meeting, to discuss the programme and timetable of the Examination took place on 21 February 2023. Following this, one of the issue specific hearings, and two open floor hearings have also taken place.

Members will be aware that at the Council meeting on 25 February 2021, a motion was passed to object to the principle of the proposal for an energy from waste facility in Wisbech. A further Notice of Motion re-stating opposition to the scheme to reassure residents of the council's consistency in this is due to be considered at council on 9 March 2023.

This in principle objection from the Council has been repeated and confirmed in other responses to the Planning Inspectorate, as part of this formal process.

**Recommendation:** That the planning committee:

## 1.0 Background

- 1.1 Members will be aware that the project known as the Medworth Energy from Waste combined power and heat plant facility, was submitted for a Development Consent Order (DCO) to the Secretary of State, in July 2022. It was submitted to the Secretary of State as it qualifies as a Nationally Significant Infrastructure Project (NSIP), due to the amount of electricity the plant generates. The DCO, which is similar to a grant of planning permission, will be heard at an Examination carried out in public by the Planning Inspectorate, who will make a recommendation to the Secretary of State, who in turn will make the final decision. The Examination will be carried out under the procedural rules relating to such NSIP projects, specifically the Infrastructure Planning (Examination Procedure) Rules 2010.
- 1.2 The energy from waste plant is located off Algores Way in Wisbech, Cambridgeshire, but the associated grid connection is in west Norfolk. It connects to a sub-station in Walsoken.

### 2.0 Update

- 2.1 The public facing parts of the Examination opened with the Preliminary Meeting, one Issue Specific Hearing and two Open Floor Hearing sessions, which took place between the 21<sup>st</sup> and 23<sup>rd</sup> February 2023.
- 2.2 The Preliminary meeting was to discuss the initial assessment of the principal issues to be discussed at Examination, the draft timetable put forward, and arrangements for the Examination. The next day, the 22 February, there was the first of the Issue Specific Hearings, relating to the need for the proposed development, alternatives and issues relating to compulsory acquisition.
- 2.3 On the evening of the 22 February, and on the 23 February, there were Open Floor Hearing Sessions, where Councillors (including from this Council), members of the public and other interested parties, were able to put their case to the appointed Inspector.

#### 3.0 Next Steps

- 3.1 The next deadline (set out in the current timetable as Deadline 1) set by the Examining Authority is the 10<sup>th</sup> March 2023, and this is when the Council will participate or submit some or all of the following:
  - A joint Local Impact Report with Norfolk County Council;
  - Draft Statement of Common Ground;
  - A summary (no more than 1500 words) of the Relevant Representations already submitted;
  - Post-hearing submissions, including written submissions of oral cases from the previous Open Floor Hearings; and
  - Details of Interested Parties to be heard at a subsequent Open Floor Hearing.
- 3.2 At the 24<sup>th</sup> March 2023 Examining Authority deadline (Deadline 2), the Council will need to submit:
  - Written Representations (WR's).
- 3.3 Many of the Issue Specific Hearings will not need officers to attend from this authority, although that will be depend on the issue to be discussed on any given session. The proposed Statement of Common Ground (SoCG) which is required to be completed and includes this council, is a document that will evolve through the process, and will not be finalised until the summer. The Examination is due to

conclude in August 2023.

- 3.4 The Examining Authority's Rule 6 letter contains a draft timetable (Appendix 1) with further scheduled dates, along with other information about the Examination.
