### Financial Assistance Small Grants Scheme

#### Summary

This report details the decisions made in relation to the Small Grants Scheme, both capital and revenue awards, for the 2023/24 financial year.

#### Recommendation

To approve the decisions set out below.

#### Reason for Decision

Determination of applications under the above Scheme.

The Small Grants Scheme Panel met on 29<sup>th</sup> January 2024 to assess revenue grant applications, and on 31<sup>st</sup> January 2024 for capital applications. These grants fall within the Health, Wellbeing and Public Protection Directorate. This report details the recommendations made by the Portfolio Holder.

The recommendations featured in this report are subject to the 'call in' procedure. When the call-in process has passed, all applicants will be notified in writing by the Norfolk Community Foundation on behalf of the Borough Council. All terms and conditions of the grants will be stated in the official offer letter.

#### **Awards over £5,000:**

##### **Walpole St Peter Parish Hall**

A grant is requested to demolish and rebuild the village hall. The village hall is very well used and the majority of the project funding is already in place. The total cost of the project is £381,000, with £340,000 already having been raised.

The usage and impact of the parish hall is very strong within the community and for many residents is the only opportunity to leave their homes and have access to both hobbies and social interaction. There is little public transport close by, and with many of the older residents not having access to a car, they would be housebound and lonely without their regular visits to the hall.

**Decision: A grant of £10,000 to be awarded towards the demolition and rebuild of the parish hall.**

##### **West Norfolk Lawn Tennis Club**

A grant is requested towards the resurfacing of the Club's two existing hard courts with a new synthetic grass surface.

This project fits well with encouraging healthier and safer lifestyles for the whole community. With the improved facilities there are aspirations to grow the club. A number of the community have supported the application, including a local GP, all highlighting the benefits of playing sports such as tennis.

**Decision: A grant of £10,000 to be awarded towards the new synthetic surfaces.**
