


Dear Sam

I imagine a number of colleagues already know my love of football (in younger days I was a qualified referee and have had my eyesight and parentage questioned in grounds as far afield as London and the Kent coast) .

On 4 June 2020 I was appointed a director of Linnets in the Community, a new venture of King's Lynn Town FC which has been registered at Companies House. This is a private limited company whose nature of business is sport and recreation education, other human health activities, and other sports activities. There are 5 other directors (they include football club owner Stephen Cleeve and our football commercial manager Mark Hearle) . Our London based solicitors are presently finalising the first draft of the charity application - when it's granted charity status , as you are probably aware we will act as trustees.
